MEMORANDUM DECISION
AND ORDER OVERRULING
OBJECTION OF MAGISTRATE
JUDGE DECISION

Case No. 2:16-CV-304-TS-EJF

This matter is before the Court on Defendants' Objection of Magistrate Judge Order Awarding Attorneys' Fees and Costs to Relator dated December 31, 2019.¹ For the reasons discussed below, the Court will overrule the objection.

Under 28 U.S.C. § 636(b)(1)(A) and Rule 72(a) of the Federal Rules of Civil Procedure, the Court reviews a Magistrate Judge's orders on nondispositive matters under a clearly erroneous or contrary to law standard.² "The clearly erroneous [or contrary to law] standard . . . requires that the reviewing court affirm unless it 'on the entire evidence is left with the definite and firm conviction that a mistake has been committed.'"³


