## MEMORANDUM DECISION AND ORDER ADOPTING REPORT AND RECOMMENDATION

The Report and Recommendation issued by United States Magistrate Judge Furse on January 26, 2018 recommends Plaintiffs' Amended Complaint<sup>1</sup> be dismissed for lack of standing and the Motion to Amend<sup>2</sup> be denied as futile for the same reasons.<sup>3</sup>

The parties were notified of their right to file objections to the Report and Recommendation within 14 days of its service pursuant to 28 U.S.C. § 636 and Fed. R. Civ. P. 72. On February 8, 2018, Plaintiffs filed a Motion for Extension of Time.<sup>4</sup> The Plaintiffs' Motion for Extension of Time was granted and the deadline to file objections to Magistrate Judge Furse's Report and Recommendation was extended to February 20, 2018.<sup>5</sup> No party filed a

written objection to the Report and Recommendation by the deadline. On February 26, 2018, Plaintiffs John Gunter, Jr. and Whitney Kohl filed objections.<sup>6</sup> These objections are untimely and will not be considered. Therefore, the analysis and conclusion of the Magistrate Judge are accepted and the Report and Recommendation<sup>7</sup> is adopted in its entirety.

## ORDER

IT IS HEREBY ORDERED that the Report and Recommendation<sup>8</sup> is ADOPTED and this case is DISMISSED without prejudice.

The Clerk is directed to close the case.
