This matter is before the Court on Plaintiff's Memorandum in Opposition to Miller Defendants' Motion for Summary Judgement. Defendants filed their Motion for Summary Judgement on October 16, 2018. Under DUCivR 7-1(3), Plaintiff's memorandum in opposition was due within 28 days after receiving service. However, Plaintiff requested and was granted an extension by the Court to file his opposition by 4:30 p.m. on November 20, 2018. Plaintiff failed to file by that deadline.
