The Report and Recommendation<sup>1</sup> issued by United States Magistrate Judge Jared C.

Bennett on February 25, 2021 recommends that Plaintiff's Motion for Leave to File an Amended Complaint<sup>2</sup> be denied.<sup>3</sup> Magistrate Judge Bennett recommended this course of action because he concluded that Plaintiff's proposed excessive force claims are futile because they are subject to dismissal.<sup>4</sup> Furthermore, Plaintiff's proposed state-law claims are likewise futile because exercising supplemental jurisdiction over them is not proper in the absence of any viable federal claims.<sup>5</sup>

The parties were notified of their right to file objections to the Report and Recommendation within 14 days of its service pursuant to 28 U.S.C. § 636 and Fed. R. Civ. P. 72.6 No party filed an objection.
