Petitioner, John Redmond, a former inmate at Salt Lake County Jail, filed a *pro se* petition for a writ of habeas corpus under 28 U.S.C. § 2241. See Dkt. No. 5. Petitioner has not responded to Respondent's Motion to Dismiss, which was filed on July 7, 2022. See Dkt. No. 24. Petitioner was last heard from in this case on March 16, 2022, more than five months ago. See Dkt. No. 22. As reflected in the docket, the court is also not aware of Petitioner's current address. Petitioner must inform the court of the Petitioner's current address and timely comply with court orders. See D. Utah Civ. R. 83-1.3(e).

IT IS HEREBY ORDERED that Petitioner shall file a brief, no later than October 10, 2022, showing cause why this case should not be dismissed for failure to prosecute or to comply with court orders given that he has not responded to Respondent's motion to dismiss or updated his address with the court. Failure to do so will result in this action's dismissal for failure to prosecute and to comply with the court's orders. *See* Fed. R. Civ. P. 41(b).
