Trigon Healthcare, Inc.*, 367 F.3d 212, 234 (4th Cir. 2004) (internal quotation marks and alternations omitted). Unless the plaintiff disputes the authenticity of these webpages—and it cannot—they are also subject to judicial notice. *Id.*

(explaining that on a motion to dismiss the Court may consider documents that are authentic and integral and explicitly relied on in the complaint).
