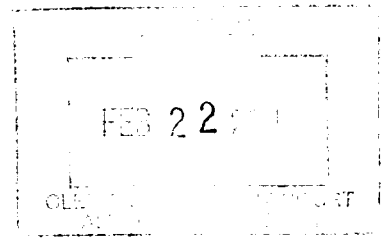

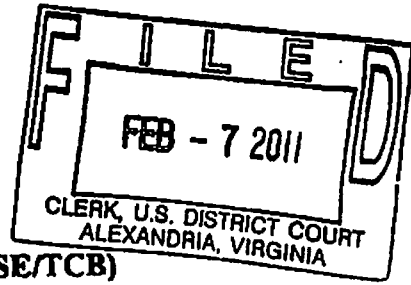

**ORDER**

By Order dated January 3, 2011, this Court dismissed this pro se petition for writ of habeas corpus under 28 U.S.C. § 2254. Petitioner filed a notice of appeal from that dismissal on January 13, 2011. He now seeks leave to proceed in forma pauperis in the appeal. To determine whether petitioner qualifies to proceed in forma pauperis, additional information will be requested from his correctional institution.

**ORDERED** that the Clerk request petitioner's institution to supply the court with an Inmate Account Report Form on petitioner within thirty (30) days of the date of this Order.

The Clerk is directed to send a copy of this Order to petitioner, a copy of this Order to the Clerk of the United States Court of Appeals for the Fourth Circuit, and a copy of this Order and the Inmate Account Report Form to petitioner's current institution of confinement.
