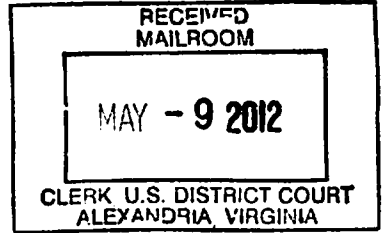
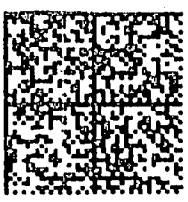
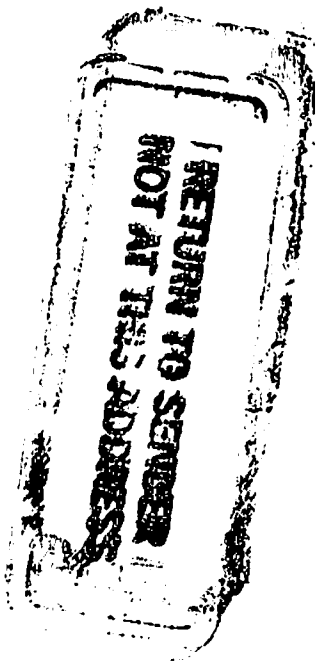

ORDER

This matter is before the Court on the Amended Report and Recommendation (Doc. No. 23) of the Magistrate Judge recommending that plaintiff Entrepreneur Media, Inc.'s motion for default judgment (Doc. 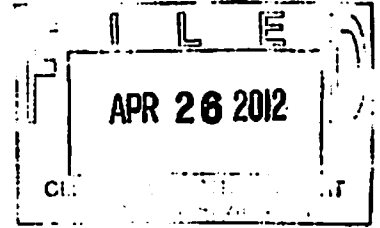
