



TRO TEMPORARY RESTRAINING ORDER

Comes Now the Plaintiff, Jonathan Lee Riches<sup>©</sup>, in pro-se, moves this  
Honorable court for declaratory Injunctive relief and to issue a TRO  
Temporary Restraining order Against Defendant's and Apple Computers  
From sexually harassing my life. Plaintiff prays for relief.

My Name is Jonathan Lee Riches<sup>©</sup>, I'm planning to move to Norfolk Virginia  
After my release from FCI Williamsburg. I fear that FCI Williamsburg  
Teacher Philip Woolston is going to use Apple computer hardware and  
Software to locate me in Norfolk to seek revenge on my life. I'm in Fear  
of Philip Woolston and below will explain why.

FCI Williamsburg Teacher Philip Woolston has been sexually harassing me and  
other inmates at FCI Williamsburg since summer of 2006. I told him numerous  
times that I'm not gay, but he continues to engage with inappropriate contact  
with me. I'm scared he might rape me at any time.

On July 15, 2006, I was in the Education Department at Ft. Williamsburg. I went to use the Bathroom. When I walked in, I saw Teacher Philip Woolston masturbating to a underage male porn book called chicken little. Woolston then asked me if I wanted to watch him finish. I said no. I told him to leave me alone and I'm going to report him to Authorities. MR. Woolston made the threat to me that if I told anyone that he would accuse me of Assaulting him and he will also come and find me to hurt me if I told and come to Virginia to hurt me.

From July 2006 through September 2007, Teacher Woolston has been subjected me to Non Stop sexual harassment. Every morning when I go to the Education department, Woolston blows Kisses at me. He touches me with his hands. MR. Woolston carries a Apple I-phone in his hand. he started doing this in July 2007. On the Morning of July 28, 2007, I was in the restroom in the Education Department. Woolston came in on me, and try to sodomize me in my rectum with his Apple I-phone. I felt scared and felt like screaming, but Woolston reminded me again that he will accuse me of Assault if I tell anyone. Woolston also told me he is personal friends with Steve Jobs, Woolston told me that Steve Jobs would provide Woolston with software databases to look up my mother who lives in Norfolk Virginia and come to Virginia to do me and her harm. if I don't have sex with him. I refused to have sex with Philip Woolston

On the Morning of Sep. 24<sup>th</sup>, 2007, I was in the Bathroom at the Education Department at Ft. Williamsburg. Teacher Woolston came in on me and approached me from behind and put his tongue in my ear. I felt horrified. Woolston smiled and said You Know You want me. I told him enough is enough and I'm telling the warden and captian. I went back to my computer in the Education Department to gather my things. It was around 10:45 am. Woolston follows me and Announces that its lunch time. I pick up my possessions and proceed to leave. I realized that I forgot to turn off my computer. I go over to turn it off and Woolston puts his hand in the way to block my

Hand. My Pointer finger touches his palm. Woolston Smiled and said I got you boy. Woolston used his radio to call back up, I proceeded to go to the chow hall when I was intercepted and escorted to medical for a Assault on staff incident report that Woolston filed. I went to medical, I was stripped down, Photos were taken of my body, and I was placed in the Special Housing unit "SHU", I demanded a investigation and told the Administration that this is a plot by Woolston because I rejected his sexual Advances. The Staff told me what ever Woolston does to you is his business. I went on a hunger strike out of fear that Woolston or someone might poison my food. 24 hrs later, the Captain informed me that Woolston is now not accusing me of assault but instead giving me a incident report for not following a order. The Captain also told me not to say anything to anyone about Woolstons Sexual Assault or Woolston will bring back assault charges against me and I would be held in the Special housing unit for Years.

I'm very Scared that Woolston is going to rape or make new accusations against me. Woolston ALready falsed Documents, he already harassed me. Plaintiff moves this Honorable court to have the Bureau of Prisons conduct a internal Affairs investigation on Woolstons conduct, and moves this Honorable court to keep Woolston away from me. I fear I will be set up by Woolston Again. I also don't want him sexually harassing anyone else Again. Plaintiff prays this court for relief
