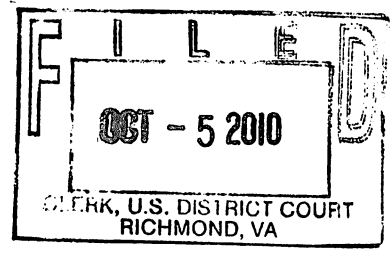

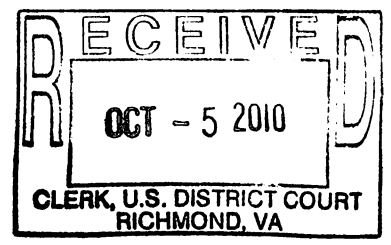

The most important reason for my request for Intervention is the fact that BARACK OBAMA IS AN ILLEGAL PRESIDENT , As is proven in EXHIBITS B1 and B2, attached hereto and made a part hereof by this reference. Therefore, any and all actions which have been made, are being made and/or are proposed to be made^{BY HIM} are NULL AND VOID.

I submit then that the illegally obtained alleged HEALTHCARE BILL, WAS NOT ONLY OBTAINED BY ILLEGAL MEANS . 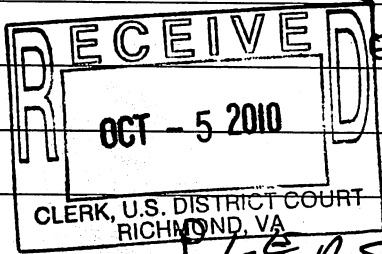

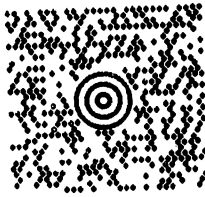

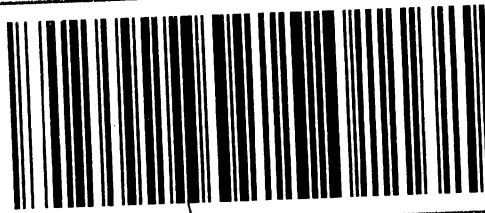
