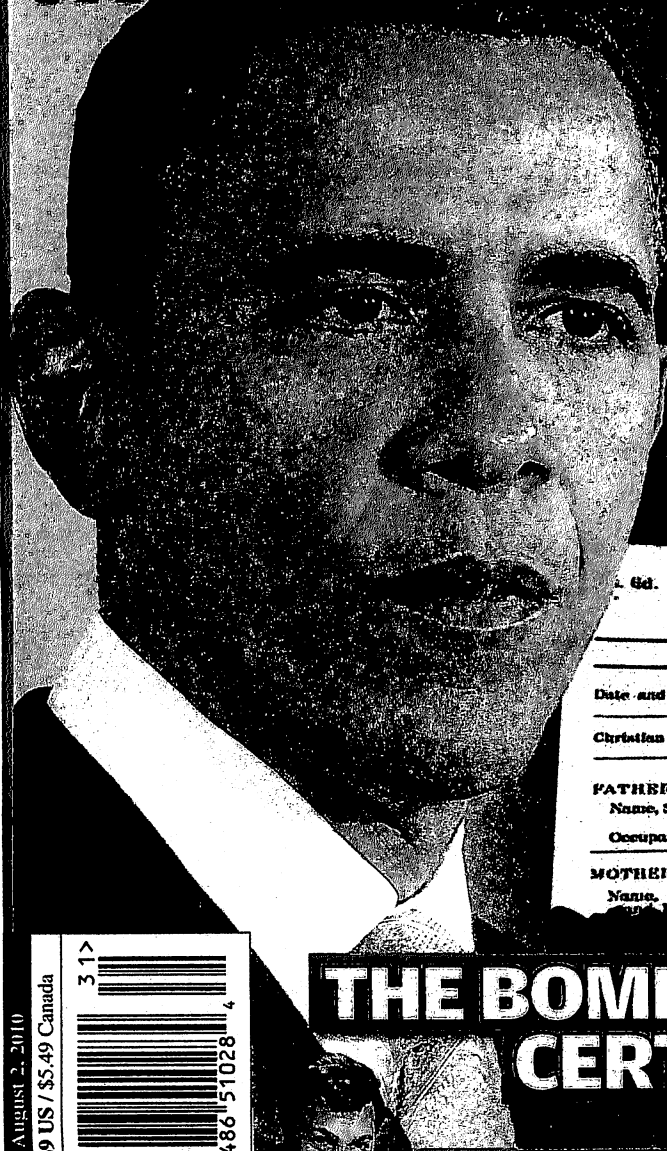

FOUND! OBAMA AFRIC

IN a bombshell development, a Kenyan birth certificate for Barack Obama has surfaced to prove he was born 8,000 miles away from America – and his presidency is illegal!

Impeachment

certificate shows the 48-year-old's birth REALLY took place in M o m b a s a , Kenya's Coast Province General Hospital at 7:24 p.m. on Aug. 4, 1961.

"This new development is HUGE," proclaims a Washington insider. "If the Kenyan document is real, it will be the smoking gun that finally answers the question of where Obama comes from."

Investigative journalists are now actively probing the mystery and warn that the results could bring a sudden and disastrous end to Obama's time in the Oval Office.

"If we find that he was not born in Hawaii, we will turn our evidence over – and he will likely be impeached," Floyd Brown, president of the Western Center for Journalism, tells GLOBE. "This is potentially the greatest single fraud ever perpetrated on the American people."

Obama, 48, has provided a Certificate of Live Birth showing that he was born in Honolulu – but he has stubbornly refused to release the official long-form certificate to prove his birthplace beyond a doubt and back up his eligibility to hold the highest office in the land.

Brown can think of only one logical reason Obama is refusing to share his official birth certificate with the public.

"He must have something to hide," says Brown. "He could put this whole issue to rest in 30 seconds just by providing the long-form certificate."

Bolstering the African birth certificate's legitimacy, separate claims have been publicly made in Kenya that the Democratic politician was born there.

And African evangelist the Rev. Kweli Shuhubia insists it is "common knowledge" that Obama was born in Mombasa, not Honolulu.

Doesn't qualify

The exact location of Obama's birth is important because a clause in the Constitution requires the President to be a "natural born citizen." If Obama was born in Kenya, experts say he doesn't qualify for the office - even though his mother was American.

Obama, a former U.S. senator from Illinois, and his camp have steadfastly maintained that he was born in a Honolulu hospital. In 2008, his campaign released the Certificate of Live Birth to prove his eligibility to be President.

But controversy continues to swirl around Obama's Hawaiian claims.

As GLOBE reported in its July 12, 2010, issue, Timothy Adams, who was a senior government elections clerk in Honolulu during the 2008 presidential race, says he searched for

Obama's long-form birth certificate and never found it.

"I was informed by my boss that we do not have Obama's birth record," he says.

And other critics, including former presidential candidate Al Keyes, say the Certificate of Live Birth is of "questionable authenticity" that "differs from the bold designs of others printed during the same time period." Others have branded the document a forgery.

Currently, at least 17 different people have challenged Obama's legal status in lawsuits - and Republican Louisiana Sen. David Vitter declares, "I support conservative legal organizations and the one who would bring that to court."

Numerous campaigns to impeach Obama have also sprung up on the Internet. Sources say the Kenyan birth certificate is sure to add fuel

to the firestorm.

Still, there are troubling questions about the Kenyan birth certificate, which is signed by the deputy registrar of Coast Province Joshua Simon Oduy and allegedly issued as a certified copy of the original on Feb. 1964.

Skeptics call the document a fake, noting that a line refers to the "Republic of Kenya" when it was actually called the "Dominion" of Kenya until December 1964.

"But Kenya's official independence from Britain was granted in 1963, which gives the document more credibility," counters a researcher at American Constitution.

However, Hawaii State Department of Health Director Chiyome Fukino insists she can verify that Obama is a natural born citizen. And the state's Republican Gov. Linda Lingle also flatly states that Obama was born at Honolulu Kapi'olani hospital.

Despite those assertions, prominent government officials have troubling questions remain.

"What's he hiding?" asks a source. "All he has to do is authorize Hawaii to publicly issue a certificate and it's all over."

"Why Obama won't take a simple step is unclear - unless he's afraid the truth will come out and ruin him!"
