3. Jerry Kilgore. Mr. Kilgore is the former Attorney General of Virginia, former general counsel to the Republican Party of Virginia, and the Virginia Chairman of the Perry Campaign. Mr. Kilgore is expected to testify about the legislative history of Va. Code § 24.2-545, the Republican Party of Virginia's efforts to comply with the statute, and the Commonwealth's interest in the requirements of the statute. Mr. Kilgore is also prepared to testify that neither the number of signature requirement nor the restrictions on petition circulators in Virginia's rule and regulations are designed to meet a legitimate state interest as it relates to whom a political party may allow on the party's primary ballot for the office of President of the United States.
