Plaintiff Quentin McLean, a Virginia prisoner proceeding <u>prose</u>, brings this action for damages pursuant to 42 U.S.C. § 1983. However, this court has dismissed three of McLean's previous complaints for failure to state a claim pursuant to 28 U.S.C. § 1915(e)(2)(B)(ii). Therefore, McLean may not proceed with this action unless he either pays the \$250.00 filing fee or shows that he is "under imminent danger of serious physical injury." 28 U.S.C. § 1915(g).

As McLean has neither prepaid the filing fee nor demonstrated that he is "under imminent danger of serious physical injury," the court dismisses his complaint without prejudice and denies his motion to proceed in forma pauperis pursuant to 28 U.S.C. § 1915(g).²

The Clerk is directed to send a certified copy of this memorandum opinion to the plaintiff.
