Before the Court is the Government's Motion to Dismiss the Civil Forfeiture Complaint. ECF No. 16. Plaintiff is represented by Assistant United States Attorney James A. Goecke. The Defendant claimant Angel Vera Campos is proceeding *pro se*. This matter was heard without oral argument.

The Government moves the court for an order dismissing the abovecaptioned action pursuant to Fed. R. Civ. P. 41(a)(2), with prejudice and with each party bearing its own costs, fees, and other expenses. ECF No 16 at 1. The Government asserts that this forfeiture action has been resolved pursuant to a plea agreement filed in the related criminal case, 2:11-CR-0109-RMP. *Id*. Further, the Government notes that it complied with the notice requirements in both the civil forfeiture process and the criminal forfeiture process. *Id*. at 2-3.
