11 The Court previously granted Plaintiff's Motion to Enforce Settlement
12 Agreement, ordering Ms. Peiper to pay Plaintiff \$45,000.00 USD. ECF No. 59.
13 Ms. Peiper indicates that she has paid Plaintiff \$31,980.00 USD in partial
14 satisfaction of the amount ordered by the Court, such that \$13,020.00 USD remains
15 to be paid. ECF No. 63.

16 Thus, in accordance with the Order Granting Motion to Enforce Settlement
17 Agreement, **IT IS HEREBY ORDERED** that Plaintiff, Bruce P. Kriegman, solely
18 in his capacity as Liquidating Trustee of LLS America, LLC as consolidated, is
19 awarded Judgment against defendant Martina Peiper, as follows:

- 20 a. Judgment \$13,020.00 USD
- b. Prejudgment interest (0.47% per annum \$370.68 USD
from July 21, 2009, to June 17, 2015)

1 c. Plus taxable costs in the amount to be
2 determined by the Court

3 d. Plus post-judgment interest from the date
4 of Judgment until fully paid at the federal
rate of 0.24% per annum (28 U.S.C. §
1961)

5 The District Court Clerk is directed to enter this Order and provide copies to
6 counsel.
