ORDER GRANTING JOINT  
MOTION TO STRIKE MOTION TO  
DISMISS; ALLOWING FILING OF  
AMENDED COMPLAINT

16 BEFORE THE COURT is the parties' Joint Motion to Strike Defendants' Motion to  
17 Dismiss (ECF No. 50) and Joint Motion to Expedite the Motion to Strike (ECF No. 51).  
18 The parties additionally request that the court grant permission for Plaintiffs to file a  
19 Second Amended Complaint.

20 Plaintiffs' First Amended Complaint listed sixteen Claims for Relief, all stemming  
21 primarily from allegations that Defendant K.C. Craven, a teacher in Defendant Lake  
22 Chelan School District, sexually abused minor C.B., which also caused harm to twin  
23 sibling J.B. Plaintiffs' Fifth, Seventh, Ninth, and Twelfth Claims for Relief listed their  
24 parents, Chris and Sara Bishop, as injured parties. Defendants' Motion to Dismiss (ECF  
25 No. 28) sought to dismiss these claims on grounds that Defendants owed no legal duty of  
26 care to the parents. The hearing on the Motion to Dismiss is currently set for December  
27 12, 2014.

1 In response, Plaintiffs have submitted a proposed Second Amended Complaint  
2 (ECF No. 50-1) which does not include the Claims for Relief that Defendants sought to  
3 dismiss. Because all parties have provided written consent for the Second Amended  
4 Complaint, such request is proper under Fed.R.Civ.P. 15(a)(2).

5 **IT IS HEREBY ORDERED:**

6 1. The Joint Motion to Strike Defendants' Motion to Dismiss (ECF No. 50) is  
7 **GRANTED.**

8 2. Defendants' Motion to Dismiss (ECF No. 28) and the December 12, 2014  
9 hearing thereon are hereby **STRICKEN.**

10 3. The Joint Motion to Expedite the Joint Motion to Dismiss and Allowing Filing  
11 of Amended Complaint (ECF No. 51) is **GRANTED.**

12 **IT IS SO ORDERED.** The Clerk is hereby directed to enter this Order and furnish  
13 copies to counsel.
