12 This matter having come on regularly for hearing on the Plaintiff's Notice  
13 of Presentment made pursuant to FRCP 58(a) and 58(d), and the Court having  
14 previously entered findings of fact and conclusions of law, ECF No. 83,  
15 determining that the judgment would be entered in the amount of \$34,601.37  
16 CAD, plus pre-judgment interest and post-judgment interest, and the Court being  
17 fully advised in the premises, it is **HEREBY ORDERED, DECREED AND  
ADJUDGED** that:

18 1. Plaintiff, Bruce P. Kriegman, solely in his capacity as Liquidating  
19 Trustee of LLS America, LLC as consolidated, is hereby awarded Judgment

1 against defendant Shanna Bowolin and Matthew Bowolin, jointly and severally,  
2 as follows:

- 3 a. Judgment \$34,601.37 CAD
- 4 b. Prejudgment interest (0.47% per \$ 1,031.45 CAD  
5 annum from July 21, 2009 to  
6 November 19, 2015 - 2,315 days)
- 7 c. Plus post-judgment interest from  
8 the date of Judgment until fully  
9 paid at the federal rate of 0.23%  
10 per annum as of 10/16/2015 (28  
11 U.S.C. § 1961).

12 2. All proofs of claim filed by Shanna Bowolin or Matthew Bowolin in  
13 the Debtor's bankruptcy or any claims that may hereafter arise are disallowed  
14 pursuant to 11 U.S.C. § 502(d) unless and until the avoided transfers paid to  
15 Shanna Bowolin and Matthew Bowolin are returned to the Trustee.

16 The District Court Clerk is directed to enter this Order and provide copies  
17 to counsel, to pro se defendants and to Judge Frederick P. Corbit.
