ORDER ADOPTING MAGISTRATE'S
REPORT AND RECOMMENDATION;
CLOSING FILE

12 BEFORE THE COURT is Magistrate Judge John T. Rodgers' Report and
13 Recommendation to Close File (ECF No. 7) on Ronald James Davenport's Original Bill in
14 Equity, which was filed on November 18, 2014. Mr. Davenport filed this action against
15 the Commissioner of the IRS and two Assistant U.S. Attorneys in connection with prior
16 litigation regarding alleged income tax withholding. On December 16, 2014, Mr.
17 Davenport filed an incomplete Application to Proceed *In Forma Pauperis*. Magistrate
18 Rodgers entered an Order denying the application, which explained how Mr. Davenport
19 could remedy the defects and directed that he do so within thirty days. No action was
20 taken by Mr. Davenport. Magistrate Rodgers then filed his Report and Recommendation
21 to Close File on January 20, 2015. Mr. Davenport has not responded to the Order or
22 Report and Recommendation.

23 Fed.R.Civ.P. 72 states that a party has 14 days after being served a copy of a
24 dispositive Report and Recommendation to file written objections. If no objections are
25 filed, then the district court need only satisfy itself that there is no clear error on the face
26 of the record in order to accept the Report and Recommendation. *Campbell v. U.S. Dist.*

ORDER - 1

1 *Court*, 501 F.2d 196, 206 (9th Cir. 1974). The court finds no clear error and therefore
2 adopts Magistrate Rodgers' Report and Recommendation and orders the file closed.

3 **IT IS HEREBY ORDERED:**

4 1. Magistrate Rodgers' Report and Recommendation to Close File (ECF No. 7) is
5 **ADOPTED.**

6 2. Mr. Davenport's Bill in Equity (ECF No. 1) is **DISMISSED** and his file is
7 **CLOSED.**

8 **IT IS SO ORDERED.** The Clerk is hereby directed to enter this Order and furnish
9 a copy to Mr. Davenport and close file.
