ORDER DISMISSING HABEAS
ACTION

12 By Order filed May 8, 2017, the Court advised Petitioner of the deficiencies of
13 his habeas petition and directed him to amend, ECF No. 15. Specifically, Petitioner had
14 not named his present custodian as Respondent, thus depriving this Court of personal
15 jurisdiction. *Dunne v. Henman*, 875 F.2d 244, 249 (9th Cir. 1989); *Brittingham v.*
16 *United States*, 982 F.2d 378, 379 (9th Cir. 1992).

17 Petitioner was granted additional time, until September 12, 2017, to comply with
18 the Court's directive. ECF No. 18. Petitioner, whose last address is at the Spokane
19 County Jail, is proceeding *pro se* and *in forma pauperis*; Respondent has not been
20 served. Petitioner did not comply with the directives of this Court and has filed nothing
further in this action.

ORDER DISMISSING HABEAS ACTION -- 1

1 For the reasons set forth above and in the Court's prior Order, **IT IS ORDERED**
2 this habeas action is **DISMISSED without prejudice** for lack of jurisdiction.

3 **IT IS SO ORDERED.** The Clerk of Court shall enter this Order, enter judgment
4 for Respondent, forward copies to Petitioner at his last known address and close the
5 file. The Court certifies that pursuant to 28 U.S.C. § 1915(a)(3), an appeal from this
6 decision could not be taken in good faith, and there is no basis upon which to issue a
7 certificate of appealability. 28 U.S.C. § 2253(c); Fed. R.App. P. 22(b).
