3 Before the Court, without oral argument, is the Plaintiff Pasco Sanitary
4 Landfill NPL Site Industrial Waste Area Generator Group III's ("IWAG III")
5 Motion for Voluntary Dismissal of Defendant Hoffman Corporation, ECF No. 92.

6 Plaintiff moves for voluntary dismissal of Hoffman Corporation from this case
7 without prejudice pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(i).
8 Hoffman Corporation has not filed an answer or a motion for summary judgment
9 in this case. Having reviewed the files and records herein, the Court finds good
10 cause to grant the motion.

11 1. Plaintiff's Motion for Voluntary Dismissal of Defendant Hoffman
12 Corporation, **ECF No. 92**, is **GRANTED**.

13 2. All claims against Defendant Hoffman Corporation are
14 **DISMISSED WITHOUT PREJUDICE**, with all parties to bear
15 their own costs and attorneys' fees.


