**ORDER GRANTING  
DEFENDANT’S MOTION FOR  
SUMMARY JUDGMENT**

Before the Court are the parties’ cross-motions for summary judgment, ECF Nos. 14 & 15. Ms. Crume brings this action seeking judicial review, pursuant to 42 U.S.C. § 405(g), of the Commissioner’s final decision, which denied her application for Disability Insurance Benefits under Title II and her application for Supplemental Security Income under Title XVI of the Social Security Act, 42 U.S.C §§ 401-434, 1381-1383F. After reviewing the administrative record and briefs filed by the parties, the Court is now fully informed. For the reasons set forth

1 below, the Court **GRANTS** Defendant’s Motion for Summary Judgment and  
2 **DENIES** Ms. Crume’s Motion for Summary Judgment.

3 **I. Jurisdiction**

4 Ms. Crume filed her application for Disability Insurance Benefits and her  
5 Application for Supplemental Security Income on December 3, 2010. AR 286-303.  
6 Her alleged onset date of disability is May 15, 2005. AR 34, 286, 293.<sup>1</sup> Ms.  
7 Crume’s application was initially denied on February 18, 2011, AR 200-03, and on  
8 reconsideration on May 31, 2011, AR 209-13.

9 Hearings with Administrative Law Judge (“ALJ”) James Sherry occurred on  
10 January 21, 2014, AR 53-103, and May 12, 2014, AR 104-44. On July 11, 2014,  
11 the ALJ issued a decision finding Ms. Crume ineligible for disability benefits. AR  
12 31-48. The Appeals Council denied Ms. Crume’s request for review on May 27,  
13 2016, AR 8-11, making the ALJ’s ruling the “final decision” of the Commissioner.

14 Ms. Crume timely filed the present action challenging the denial of benefits,  
15 on December 22, 2016. ECF No. 3. Accordingly, Ms. Crume’s claims are properly  
16 before this Court pursuant to 42 U.S.C. § 405(g).

<sup>1</sup> Ms. Crume asserts that she attempted to amend the alleged onset date to 2010. Counsel for Ms.  
19 Crume mentioned at the second hearing they might possibly amend the alleged onset date to  
20 March 2010, but did not request to amend the alleged onset date, AR 117-18, but that they  
thought the original alleged onset date is fine, AR 117. Counsel for Ms. Crume submitted a post-  
hearing brief requesting the ALJ find Ms. Crume disabled as of October 2010, but did not revise  
the alleged onset date from May 15, 2005, to October 2010 or any day therein. AR 380. No  
amendment of the alleged onset date occurred, thus the alleged onset date remains May 15, 2005.



1 Step two asks whether the claimant has a severe impairment, or combination  
2 of impairments, that significantly limits the claimant’s physical or mental ability to  
3 do basic work activities. 20 C.F.R. §§ 404.1520(c) & 416.920(c). A severe  
4 impairment is one that has lasted or is expected to last for at least twelve months,  
5 and must be proven by objective medical evidence. 20 C.F.R. §§ 404.1508-09 &  
6 416.908-09. If the claimant does not have a severe impairment, or combination of  
7 impairments, the disability claim is denied, and no further evaluative steps are  
8 required. Otherwise, the evaluation proceeds to the third step.

9 Step three involves a determination of whether any of the claimant’s severe  
10 impairments “meets or equals” one of the listed impairments acknowledged by the  
11 Commissioner to be sufficiently severe as to preclude substantial gainful activity.  
12 20 C.F.R. §§ 404.1520(d), 404.1525, 404.1526 & 416.920(d), 416.925, 416.926;  
13 20 C.F.R. § 404 Subpt. P. App. 1 (“the Listings”). If the impairment meets or  
14 equals one of the listed impairments, the claimant is *per se* disabled and qualifies  
15 for benefits. *Id.* If the claimant is not *per se* disabled, the evaluation proceeds to the  
16 fourth step.

17 Step four examines whether the claimant’s residual functional capacity  
18 enables the claimant to perform past relevant work. 20 C.F.R. §§ 404.1520(e)-(f) &  
19 416.920(e)-(f). If the claimant can still perform past relevant work, the claimant is  
20 not entitled to disability benefits and the inquiry ends. *Id.*

1 Step five shifts the burden to the Commissioner to prove that the claimant is  
2 able to perform other work in the national economy, taking into account the  
3 claimant's age, education, and work experience. *See* 20 C.F.R. §§ 404.1512(f),  
4 404.1520(g), 404.1560(c) & 416.912(f), 416.920(g), 416.960(c). To meet this  
5 burden, the Commissioner must establish that (1) the claimant is capable of  
6 performing other work; and (2) such work exists in "significant Crume in the  
7 national economy." 20 C.F.R. §§ 404.1560(c)(2); 416.960(c)(2); *Beltran v. Astrue*,  
8 676 F.3d 1203, 1206 (9th Cir. 2012).

### 9 III. Standard of Review

10 A district court's review of a final decision of the Commissioner is governed  
11 by 42 U.S.C. § 405(g). The scope of review under § 405(g) is limited, and the  
12 Commissioner's decision will be disturbed "only if it is not supported by  
13 substantial evidence or is based on legal error." *Hill v. Astrue*, 698 F.3d 1144,  
14 1158-59 (9th Cir. 2012) (citing § 405(g)). Substantial evidence means "more than a  
15 mere scintilla but less than a preponderance; it is such relevant evidence as a  
16 reasonable mind might accept as adequate to support a conclusion." *Sandgathe v.*  
17 *Chater*, 108 F.3d 978, 980 (9th Cir.1997) (quoting *Andrews v. Shalala*, 53 F.3d  
18 1035, 1039 (9th Cir. 1995)) (internal quotation marks omitted). In determining  
19 whether the Commissioner's findings are supported by substantial evidence, "a  
20 reviewing court must consider the entire record as a whole and may not affirm

1 simply by isolating a specific quantum of supporting evidence.” *Robbins v. Soc.*  
2 *Sec. Admin.*, 466 F.3d 880, 882 (9th Cir. 2006) (quoting *Hammock v. Bowen*, 879  
3 F.2d 498, 501 (9th Cir. 1989)).

4 In reviewing a denial of benefits, a district court may not substitute its  
5 judgment for that of the ALJ. *Matney v. Sullivan*, 981 F.2d 1016, 1019 (9th Cir.  
6 1992). If the evidence in the record “is susceptible to more than one rational  
7 interpretation, [the court] must uphold the ALJ's findings if they are supported by  
8 inferences reasonably drawn from the record.” *Molina v. Astrue*, 674 F.3d 1104,  
9 1111 (9th Cir. 2012); *see also Thomas v. Barnhart*, 278 F.3d 947, 954 (9<sup>th</sup> Cir.  
10 2002) (if the “evidence is susceptible to more than one rational interpretation, one  
11 of which supports the ALJ’s decision, the conclusion must be upheld”). Moreover,  
12 a district court “may not reverse an ALJ's decision on account of an error that is  
13 harmless.” *Molina*, 674 F.3d at 1111. An error is harmless “where it is  
14 inconsequential to the [ALJ's] ultimate nondisability determination.” *Id.* at 1115.  
15 The burden of showing that an error is harmful generally falls upon the party  
16 appealing the ALJ's decision. *Shinseki v. Sanders*, 556 U.S. 396, 409–10 (2009).

#### 17 **IV. Statement of Facts**

18 The facts of the case are set forth in detail in the transcript of proceedings  
19 and only briefly summarized here. Ms. Crume was 43 years old at the alleged date  
20 of onset. AR 46, 146, 286, 293. She has a high school education and specialized

1 training in cosmetology. AR 46, 334-35. Ms. Crume is able to communicate in  
2 English. AR 46. Ms. Crume last worked in 2010 as a hair dresser. AR 43, 326, 335,  
3 503.

#### 4 **V. The ALJ's Findings**

5 The ALJ determined that Ms. Crume was not under a disability within the  
6 meaning of the Act from May 15, 2005, through the date of the ALJ's decision.  
7 AR 47-48.

8 **At step one**, the ALJ found that Ms. Crume had not engaged in substantial  
9 gainful activity since May 15, 2005 (citing 20 C.F.R. §§ 404.1571 *et seq.*, and  
10 416.971 *et seq.*). AR 37.

11 **At step two**, the ALJ found Ms. Crume had the following severe  
12 impairments: diabetes mellitus, hyperthyroidism, mood disorder, anxiety disorder,  
13 and substance abuse (citing 20 C.F.R. §§ 404.1520(c) and 416.920(c)). AR 37.

14 **At step three**, the ALJ found that Ms. Crume did not have an impairment or  
15 combination of impairments that meets or medically equals the severity of one of  
16 the listed impairments in 20 C.F.R. § 404, Subpt. P, App. 1. AR 37.

17 **At step four**, the ALJ found Ms. Crume had the residual functional capacity  
18 to perform light work, with the following limitations: she can occasionally climb  
19 ladders, ropes, or scaffolds; she can frequently balance, stoop, crouch, kneel, and  
20 crawl; she should avoid concentrated exposure to extreme cold, extreme heat,

1 excessive vibration, unprotected heights, and use of moving machinery; she can  
2 perform simple, routine, and repetitive tasks and some well learned complex tasks;  
3 she can perform occasional and simple decision-making; she can have occasional  
4 and simple changes in the work setting; she should have no fast-paced production  
5 requirements; she can maintain concentration for two-hour segments for simple  
6 tasks without more than normally expected brief interruptions; she can have  
7 superficial contact with the general public, coworkers, and supervisors. AR 39.

8 The ALJ determined that Ms. Crume can perform her past relevant work as a  
9 cosmetologist. AR 45.

10 **At step five**, the ALJ found that, in addition to her past relevant work as a  
11 cosmetologist and, in light of her age, education, work experience, and residual  
12 functional capacity, in conjunction with the Medical-Vocational Guidelines, there  
13 are jobs that exist in significant numbers in the national economy that Ms. Crume  
14 can perform. AR 45-47. Specifically, the ALJ determined that Ms. Crume can  
15 perform the jobs of cashier II, cleaner, housekeeper, and storage facility rental  
16 clerk. AR 47.

## 17 **VI. Issues for Review**

18 Ms. Crume argues that the Commissioner's decision is not free of legal error  
19 and not supported by substantial evidence. Specifically, she argues the ALJ erred  
20 by: (1) failing to fully and fairly develop the record; (2) improperly discrediting



1 Ms. Crume’s subjective complaint testimony; and (3) improperly evaluating the  
2 medical and lay witness opinion evidence.

## 3 **VII. Discussion**

### 4 **A. The ALJ Did Not Fail to Fully and Fairly Develop the Record.**

5 Ms. Crume argues the ALJ failed to meet his duty to develop the record by  
6 failing to obtain purported records regarding treatment by Nurse Hanks and  
7 without those records there was insufficient evidence to allow for a proper  
8 evaluation of Nurse Hanks’ opinion.

9 In Social Security cases, the ALJ has a special duty to develop the record  
10 fully and fairly and to ensure that the claimant's interests are considered, even  
11 when the claimant is represented by counsel. *Tonapetyan v. Halter*, 242 F.3d 1144,  
12 1150 (9th Cir.2001); *Brown v. Heckler*, 713 F.2d 441, 443 (9th Cir.1983). The  
13 regulations provide that the ALJ may attempt to obtain additional evidence when  
14 the evidence as a whole is insufficient to make a disability determination, or if after  
15 weighing the evidence the ALJ cannot make a disability determination. 20 C.F.R. §  
16 404.1527(c)(3); see also 20 C.F.R. § 404.1519a. Importantly, “[a]n ALJ's duty to  
17 develop the record further is triggered only when there is ambiguous evidence or  
18 when the record is inadequate to allow for proper evaluation of the evidence.”  
19 *Mayes v. Massanari*, 276 F.3d 453, 459–60 (9th Cir. 2001); *Tonapetyan*, 242 F.3d  
20 at 1150. “The ALJ may discharge this duty in several ways, including:

1 subpoenaing the claimant's physicians, submitting questions to the claimant's  
2 physicians, continuing the hearing, or keeping the record open after the hearing to  
3 allow supplementation of the record." *Tonapetyan*, 242 F.3d at 1150 (citing  
4 *Tidwell v. Apfel*, 161 F.3d 599, 602 (9th Cir. 1998); *Smolen v. Chater*, 80 F.3d  
5 1273, 1288 (9th Cir. 1996)).

6 The ALJ did not fail to develop the record in the case at hand. The record  
7 before the ALJ was neither ambiguous nor inadequate to allow for proper  
8 evaluation of the disability claim. Substantial evidence supports the ALJ's decision  
9 that Ms. Crume is not disabled. Additionally, counsel for Ms. Crume repeatedly  
10 stated that there were no missing medical records that would trigger the  
11 requirement to further develop the record and the ALJ discharged any duty to  
12 further develop the record by keeping the record open after both hearings to allow  
13 supplementation of the record.

14 At the first hearing in January 2014, counsel for Ms. Crume stated the he  
15 had submitted all of the records from the clinic where Nurse Hanks worked. AR  
16 57. Even so, the ALJ continued the hearing to allow Ms. Crume to order any  
17 additional records since there were so few mental health treatment records in her  
18 case. AR 77-79, 100. The second hearing took place in May 2014, allowing  
19 sufficient time to supplement the record, and Ms. Crume did not submit any  
20 additional records from the clinic where Nurse Hanks worked. AR 104-44. At the

1 May 2014 hearing, counsel for Ms. Crume stated again that the record was  
2 complete, AR 108, that counsel had contacted Nurse Hanks' office, and Nurse  
3 Hanks' office explained that they had provided counsel with all of the treatment  
4 records. AR 110. In the same May 2014 hearing, counsel for Ms. Crume again  
5 confirmed that he had followed up with all health care providers and had been told  
6 there were no additional records. AR 130-31. At the end of the May 2014 hearing,  
7 counsel for Ms. Crume confirmed yet again that he had been told by the medical  
8 providers that there were no additional records, and counsel requested the ALJ  
9 keep the record open to permit Ms. Crume to try and obtain any additional medical  
10 records. AR 141-42. Despite repeated affirmations by counsel for Ms. Crume that  
11 there were no outstanding medical records, the ALJ agreed to keep the record open  
12 for an additional 20 days. AR 141-42. No additional medical records were  
13 submitted, and counsel for Ms. Crume indicated that all the mental health records  
14 were already in the case file. AR 380.

15 Ms. Crume was given multiple opportunities to supplement the record with  
16 additional notes that purportedly existed addressing Nurse Hanks' treatment of Ms.  
17 Crume. However, no additional treatment records were submitted, and counsel for  
18 Ms. Crume continually told the ALJ that there were no missing medical records for  
19 the clinic where Nurse Hanks worked. Accordingly, the ALJ's duty to further  
20 develop the record was not triggered, and if it was triggered, the ALJ discharged

1 his duty by continuing the hearing and keeping the record open to allow  
2 supplementation of the record. *Tonapetyan*, 242 F.3d at 1150.

3 **B. The ALJ Properly Discounted Ms. Crume’s Credibility.**

4 An ALJ engages in a two-step analysis to determine whether a claimant’s  
5 testimony regarding subjective symptoms is credible. *Tommasetti v. Astrue*, 533  
6 F.3d 1035, 1039 (9th Cir. 2008). First, the claimant must produce objective  
7 medical evidence of an underlying impairment or impairments that could  
8 reasonably be expected to produce some degree of the symptoms alleged. *Id.*  
9 Second, if the claimant meets this threshold, and there is no affirmative evidence  
10 suggesting malingering, “the ALJ can reject the claimant’s testimony about the  
11 severity of [her] symptoms only by offering specific, clear, and convincing reasons  
12 for doing so.” *Id.*

13 In weighing a claimant's credibility, the ALJ may consider many factors,  
14 including, “(1) ordinary techniques of credibility evaluation, such as the claimant's  
15 reputation for lying, prior inconsistent statements concerning the symptoms, and  
16 other testimony by the claimant that appears less than candid; (2) unexplained or  
17 inadequately explained failure to seek treatment or to follow a prescribed course of  
18 treatment; and (3) the claimant's daily activities.” *Smolen*, 80 F.3d at 1284. When  
19 evidence reasonably supports either confirming or reversing the ALJ's decision, the  
20 Court may not substitute its judgment for that of the ALJ. *Tackett v. Apfel*, 180

1 F.3d 1094, 1098 (9th Cir.1999). Here, the ALJ found that the medically  
2 determinable impairments could reasonably be expected to produce the symptoms  
3 Ms. Crume alleges; however, the ALJ determined that Ms. Crume's statements of  
4 intensity, persistence, and limiting effects of the symptoms were not entirely  
5 credible. AR 40. The ALJ provided multiple clear and convincing reasons for  
6 discrediting Ms. Crume's subjective complaint testimony. AR 39-44.

7 First, the ALJ noted multiple inconsistencies with the medical evidence. AR  
8 40-43. This determination is supported by substantial evidence in the record. An  
9 ALJ may discount a claimant's subjective symptom testimony that is contradicted  
10 by medical evidence. *Carmickle v. Comm'r of Soc. Sec. Admin.*, 533 F.3d 1155,  
11 1161 (9th Cir. 2008). Inconsistency between a claimant's allegations and relevant  
12 medical evidence is a legally sufficient reason to reject a claimant's subjective  
13 testimony. *Tonapetyan*, 242 F.3d at 1148.

14 Ms. Crume alleges completely debilitating physical limitations, neuropathy  
15 in the hands and toes, and an inability to walk for only one or two blocks before  
16 needing rest, as well as difficulty with concentration and interacting with others.  
17 AR 40, 43, 346, 352. However, physical examinations were generally normal and  
18 unremarkable, including full strength, normal gait, and normal range of motion.  
19 AR 386, 433, 439, 445, 450, 456, 485, 513, 554, 604, 606, 610, 612, 614, 617, 619,  
20 621, 623, 625, 718, 797, 808. Additionally, providers repeatedly found her to be

1 cooperative with a normal mood and affect, and that she had normal attention span  
2 and concentration. AR 387, 397, 402, 411, 418, 427, 433, 439, 445, 451, 456, 461,  
3 466, 476, 480, 485, 491, 499, 501-02, 519, 565, 567, 573, 579, 581, 645, 711, 801.

4 Second, the ALJ noted several pertinent inconsistent statements. AR 43. An  
5 ALJ may rely on ordinary techniques of credibility evaluation such as a witness's  
6 prior inconsistent statements. *Tommasetti*, 533 F.3d at 1039. Specifically, Ms.  
7 Crume stated that she was unable to complete a workday. AR 43, 352. However,  
8 Ms. Crume also repeatedly stated that she worked full time as a hairdresser even  
9 after the alleged onset date in 2005 to 2010. AR 43, 335, 326, 470, 503. Ms. Crume  
10 alleged that she has difficulty interacting with others. AR 43, 346. However, she  
11 has also reported that she has no problem getting along with others and her hobbies  
12 include socializing. AR 43, 345, 352. Ms. Crume also stated she is unable to walk  
13 for more than one or two blocks but also reported one of her hobbies is working  
14 out, and that she participates in regular exercise by walking daily for about 45  
15 minutes to one hour. AR 43, 345, 611.

16 Third, the ALJ noted unexplained gaps in Ms. Crume's treatment history.  
17 AR 43. Specifically, the fact that the record contains no medical or mental health  
18 treatment records from the disability onset date of May 15, 2005, to August 2008.  
19 AR 43. A claimant's statements may be less credible when treatment is  
20 inconsistent with the level of complaints or a claimant is not following treatment

1 prescribed without good reason. *Molina*, 674 F.3d at 1114. “Unexplained, or  
2 inadequately explained, failure to seek treatment . . . can cast doubt on the sincerity  
3 of [a] claimant’s [] testimony.” *Fair v. Bowen*, 885 F.2d 597, 603 (9th Cir. 1989).

4 Fourth, the ALJ found that Ms. Crume’s activities did not support her  
5 allegations of total disability. AR 40-44. Activities inconsistent with the alleged  
6 symptoms are proper grounds for questioning the credibility of an individual’s  
7 subjective allegations. *Molina*, 674 F.3d at 1113 (“[e]ven where those activities  
8 suggest some difficulty functioning, they may be grounds for discrediting the  
9 claimant’s testimony to the extent that they contradict claims of a totally  
10 debilitating impairment”); *see also Rollins v. Massanari*, 261 F.3d 853, 857 (9th  
11 Cir. 2001).

12 Ms. Crume alleges totally disabling limitations, both physical limitations  
13 and mental limitations. However, throughout the relevant period she reported  
14 performing household chores such as laundry, dish washing cleaning bathrooms,  
15 and caring for her two children. AR 43, 93, 95, 343; *see also Morgan v. Apfel*, 169  
16 F.3d 595, 600 (9th Cir.1999) (claimant's ability to fix meals, do laundry, work in  
17 the yard, and occasionally care for his friend's child was evidence of claimant's  
18 ability to work); *Rollins*, 261 F.3d at 857 (claim to be totally disabled was  
19 undermined by “her daily activities, such as attending to the needs of her two  
20 young children, cooking, housekeeping, laundry, shopping, attending therapy and

1 various other meetings every week, and so forth”). Her reported hobbies include  
2 watching television, reading, socializing, and working out. AR 43, 345. She  
3 reported participating in regular exercise by walking daily for about 45 minutes to  
4 one hour. AR 43, 611. She reported regularly attending church and visiting with  
5 her daughter. AR 43, 345. Furthermore, Ms. Crume worked fulltime as a  
6 hairdresser after the alleged onset date, and stated that she worked eight hours a  
7 day, five days a week at least until December 2010, she walked and stood for eight  
8 hours each day, and she lifted up to 20 pounds and 10 pounds frequently. AR 44,  
9 326, 335, 470, 503.

10 The ALJ reasonably found that Ms. Crume’s daily activities contradict her  
11 allegations of total disability. The record supports the ALJ’s determination that Ms.  
12 Crume’s conditions are not as limiting as she alleges.

13 When the ALJ presents a reasonable interpretation that is supported by the  
14 evidence, it is not the role of the courts to second-guess it. *Rollins*, 261 F.3d at 857.  
15 The Court “must uphold the ALJ’s findings if they are supported by inferences  
16 reasonably drawn from the record.” *Molina*, 674 F.3d 1104, 1111; *see also*  
17 *Thomas*, 278 F.3d 947, 954 (if the “evidence is susceptible to more than one  
18 rational interpretation, one of which supports the ALJ’s decision, the conclusion  
19 must be upheld”). The Court does not find the ALJ erred when discounting Ms.



1 Crume’s credibility because the ALJ properly provided multiple clear and  
2 convincing reasons for doing so.

### 3 **C. The ALJ Properly Weighed the Medical and Lay Witness Opinion**

#### 4 **Evidence.**

##### 5 **a. Nurse Hanks**

6 The opinion testimony of Nurse Hanks falls under the category of “other  
7 sources.” “Other sources” for opinions include nurse practitioners, physicians’  
8 assistants, therapists, teachers, social workers, spouses, and other non-medical  
9 sources. 20 C.F.R. §§ 404.1513(d), 416.913(d). An ALJ is required to “consider  
10 observations by non-medical sources as to how an impairment affects a claimant’s  
11 ability to work.” *Sprague v. Bowen*, 812 F.2d 1226, 1232 (9th Cir.1987). Non-  
12 medical testimony can never establish a diagnosis or disability absent  
13 corroborating competent medical evidence. *Nguyen v. Chater*, 100 F.3d 1462, 1467  
14 (9th Cir.1996). An ALJ is obligated to give reasons germane to “other source”  
15 testimony before discounting it. *Dodrill v. Shalala*, 12 F.3d 915 (9th Cir.1993).

16 Nurse Hanks completed a mental residual functional capacity statement of  
17 Ms. Crume in February 2014. AR 734-37. Nurse Anderson opined that Ms. Crume  
18 would only be effective for twenty percent of an eight hour workday. AR 737. The  
19 ALJ assigned little weight to the opinion of Nurse Hanks because it is conclusory,  
20 provides very little explanation of any evidence relied on in forming the opinion,

1 and the opinion is inconsistent with the clinical findings of treatment providers. AR  
2 44.

3 Ms. Crume does not contend that the opinion of Nurse Hanks in the record is  
4 not conclusory and unsupported by clinical evidence; rather, Ms. Crume alleges  
5 that giving little weight to the opinion was an error because she alleges there are  
6 progress notes and office notes created by Nurse Hanks regarding the treatment of  
7 Ms. Crume that support this opinion and were erroneously not obtained by the  
8 ALJ. However, as stated above, counsel for Ms. Crume repeatedly told the ALJ  
9 that all notes and reports from Nurse Hanks' office had been obtained and  
10 submitted to the record, and the ALJ held the record open to allow Ms. Crume to  
11 supplement the record with any additional records that might be available. Nurse  
12 Hanks' opinion is conclusory and unsupported by clinical evidence. "[A]n ALJ  
13 need not accept the opinion of a doctor if that opinion is brief, conclusory, and  
14 inadequately supported by clinical findings." *Bayliss v. Barnhart*, 427 F.3d 1211,  
15 1216 (9th Cir. 2005).

16 Further, Nurse Hanks' opinion is inconsistent with the clinical findings of  
17 treatment providers. *See* AR 387, 397, 402, 411, 418, 427, 433, 439, 445, 451, 456,  
18 461, 466, 476, 480, 485, 491, 499, 501-02, 519, 565, 567, 573, 579, 581, 645, 711,  
19 801. An ALJ may reject even a doctor's opinion when it is inconsistent with other

1 evidence in the record. *See Morgan v. Comm’r of the Soc. Sec. Admin.*, 169 F.3d  
2 595, 602-603 (9th Cir. 1999).

3 Accordingly, the Court finds the ALJ did not err in his consideration of  
4 Nurse Hanks’ opinion.

5 **b. Rick Crume**

6 The opinion testimony of Ms. Crume’s husband, Rick Crume, falls under the  
7 category of “other sources.” An ALJ is required to “consider observations by non-  
8 medical sources as to how an impairment affects a claimant's ability to work.”  
9 *Sprague*, 812 F.2d at 1232. Non-medical testimony can never establish a diagnosis  
10 or disability absent corroborating competent medical evidence. *Nguyen*, 100 F.3d  
11 at 1467. An ALJ is obligated to give reasons germane to “other source” testimony  
12 before discounting it. *Dodrill*, 12 F.3d 915.

13 Mr. Crume stated that Ms. Crume has difficulty completing chores,  
14 maintaining friendships, leaving the house, and taking her medications. AR 369.  
15 The ALJ stated that he considered the statements by Mr. Crume, but that the  
16 medical evidence of record does not support finding greater limitations than those  
17 set forth in the residual functional capacity. AR 45. Inconsistency with medical  
18 evidence is a germane reason to discount other source opinion evidence. *Bayliss*,  
19 427 F.3d at 1218. Additionally, the statements made by Mr. Crume are comparable  
20 to and generally reflect the same allegations made by Ms. Crume, which the ALJ

1 properly determined were not entirely credible. *See Valentine v. Comm’r Soc. Sec.*  
2 *Admin.*, 574 F.3d 685, 694 (9th Cir. 2009) (upholding the ALJ’s rejection of a lay  
3 witness for the same reasons the ALJ rejected the claimant’s credibility); *see also*  
4 *Molina*, 674 F.3d at 1117. Further, where the ALJ rejects a witness's testimony  
5 without providing germane reasons, but has already provided germane reasons for  
6 rejecting similar testimony, we cannot reverse the agency merely because the ALJ  
7 did not “clearly link his determination to those reasons.” *Molina v. Astrue*, 674  
8 F.3d 1104, 1121 (9th Cir. 2012).

9 The ALJ properly provided germane reasons for not fully crediting Mr.  
10 Crume’s statements. Accordingly, the Court finds the ALJ did not err in his  
11 consideration of Mr. Crume’s opinion.

### 12 **VIII. Conclusion**

13 Having reviewed the record and the ALJ’s findings, the Court finds the  
14 ALJ’s decision is supported by substantial evidence and is free from legal error.

15 Accordingly, **IT IS ORDERED:**

16 1. Plaintiff’s Motion for Summary Judgment, **ECF No. 14**, is **DENIED**.

17 2. Defendant’s Motion for Summary Judgment, **ECF No. 15**, is

18 **GRANTED.**

2 **CLOSED.**
