



1           3.       As ordered, the parties have conferred. The parties anticipate there will be two  
2 Motions filed and an indeterminate number of joinders. The parties agree that the Court should  
3 order the following relief:

- 4           a.       The two Motions filed on or before October 13, 2017 will be limited to  
5 twenty-four pages each.
- 6           b.       Any party that intends to join the Motions and/or to file a brief  
7 containing argument in support of the Motions shall do so no later than  
8 October 27, 2017. Joinders shall be limited to five pages and shall not  
9 repeat arguments made in the Motions.
- 10          c.       Responsive materials in opposition to the Motions and joinders shall be  
11 filed on or before November 27, 2017. Briefs in opposition shall be  
12 limited to twenty-four pages per Motion; provided, however, that the two  
13 opposing briefs of twenty-four pages may be combined into one brief at  
14 the option of the filing party, and opposing parties will be allowed extra  
15 pages to address any argument(s) made in any brief joining the Motions,  
16 but only to the extent that such argument(s) were not raised in the  
17 Motions. Such additional pages shall be limited to the number of pages  
18 addressing such argument(s) in the filed joinders.
- 19          d.       Reply briefs shall not exceed twelve pages each.
