Re: Infringing Material on Google Video

Dear DMCA Complaints Manager:

This law firm is counsel to Square Enix, Inc. and its Japanese parent, Square Enix Co., Ltd. Square Enix is the creator and owner of all rights in the famous "Final Fantasy" series of games, motion pictures, merchandise, and other derivatives. One of Square Enix's most recent creations is the motion picture *Final Fantasy VII: Advent Children*. This film has already been released in Japan; but the film is still eagerly-awaited by fans in the United States and many other countries. Unfortunately, much of that anticipation has been damaged, and Square Enix's likely revenues reduced, by the recent availability of a full-length video of the film on your company's Google Video service.

1. The copyrighted work that has been infringed is the original film *Final Fantasy VII: Advent Children*, created and produced by Square Enix, released in Japan on September 14, 2005, and not yet released in the United States or other markets.
2. The material that infringes the copyrighted work listed in item #1 above is a downloadable video copy of the film in its entirety. This video appeared as one result in a Google Video search for the keywords "Advent" conducted by Square Enix personnel on November 2, 2005. The search result provided a link to the infringing copy of the film at the following URL:

3. Google may contact me at the email address, phone number, fax number, and/or postal address displayed on the front page of this letter.
4. We are without sufficient information to identify the owner/administrator of the Web page that displayed the infringing material. However, we suspect the individual is the same one who boasted about uploading the complete version of the film in a blog accessible at:

5. I have a good faith belief that use of the copyrighted materials described above on the infringing Web pages is not authorized by the copyright owner, its agent, or the law.

6. I swear, under penalty of perjury, that the information in the above notification is accurate, and that I am an attorney authorized to act on behalf of the copyright owner whose exclusive right has been infringed.

While we can no longer find the full-length film on the GoogleVideo engine, we videotaped the full-length film as played on GoogleVideo on November 2, 2005, and we have this videotape in hand, along with a screen-captured image from which one can confirm the date and time (both in Los Angeles time and Japan time) at which the public transmission of the film was made. That screen-capture also includes a Web link indicating www.xanga.com on the summary of the uploaded material—a link to the same site that hosts the blog referenced above.

We acknowledge your claim that:

The sites displayed as search results or linked to by Google Services are developed by people over whom Google exercises no control. The search results that appear from Google's indices are indexed by Google's automated machinery and computers, and Google cannot and does not screen the sites before including them in the indices from which such automated search results are gathered.

However, it appears to us from our research that video images located by the Google Video engine are captured and copied onto a Google server, and then displayed *from the Google server* using Macromedia Flash 7. If that is the case, then what the Google Video engine is doing is not the kind of mere pass-through of data protected by the safe harbor provisions of the Digital Millennium Copyright Act of 1998 applicable to online service providers. Rather, the unauthorized display of the film appears to emanate from a server under Google's direct control, and if this is true, then Google is susceptible to a lawsuit for both direct and contributory infringement.

In any event, as noted above, we are no longer able to locate this film on Google Video. We assume it has been taken down, either by Google or by its original source. However, my client remains deeply concerned that this infringement occurred in the first place, that its appearance on

Google Video afforded it wider distribution than it may otherwise have received, and that this distribution has damaged Square Enix's ability to benefit fully from its still-coming U.S. and international release of its film. Square Enix is entitled to redress for the damage it has suffered, and therefore demands that you promptly:


1. provide us with any and all information you have the identity of and true contact information for the person who uploaded the unauthorized copy of the film;
2. ensure that the infringing video has been permanently removed and cannot and will not be displayed in any future Google Video searches;
3. put safeguards in place to prevent any further unauthorized display of Square Enix's copyrighted works, such as *Final Fantasy VII: Advent Children*; and
4. confirm to us **in writing no later than November 28, 2005** that you have complied with these demands.

Neither this letter nor your compliance with the demands herein may be taken as a waiver of Square Enix's right to pursue legal action regarding this or any other infringement of its protected work. Square Enix expressly reserves all such rights.

We look forward to your timely reply.

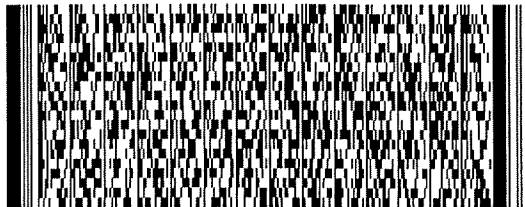
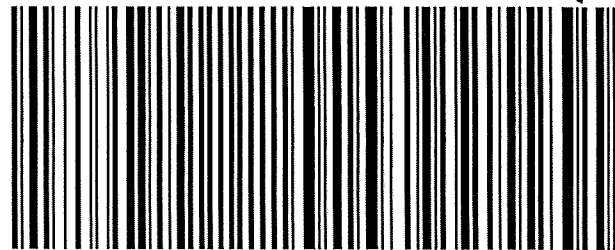
