THIS MATTER has come before the Court on Defendants' motion to compel Plaintiffs to provide complete and accurate responses to Defendant Scott Lynn's ("Lynn") First Set of Interrogatories and Requests for Production to Plaintiff Gordon (the "Gordon Requests") and his First Set of Interrogatories and Requests for Production to Plaintiff Omni Innovations, LLC (the "Omni Requests") (together, the "Discovery Requests"). Having reviewed that motion, as well as supporting documents, and the submissions of Plaintiffs in opposition thereto, the Court hereby rules as follows:

1 The Court hereby GRANTS Defendants' Motion to Compel Discovery. Within
2 ten (10) days of the date this order is signed, Plaintiffs are ORDERED to provide
3 Defendants' counsel with complete and accurate responses to the following Discovery
4 Requests:

5 Gordon Requests: Interrogatories Nos. 3, 6, 7-10, and 16-18; Requests for
6 Production Nos. 2 and 3.

7 Omni Requests: Interrogatories Nos. 3, 5, 7-10, and 15-18; Requests for
8 Production Nos. 2 and 3.

9 Plaintiffs are further ORDERED, within ten (10) days of the date this order is
10 signed, to notify Defendants' counsel whether the numbering of the responses to the
11 Gordon Requests is accurate, and if not, to provide Defendants with accurately numbered
12 responses.
