17 There is no dispute for the Court to resolve. The parties agree that the  
18 original Complaint should be sealed; Microsoft's motion should therefore be  
19 granted.

20 Immersion's attack on the substance of Microsoft's motion is unwarranted.  
21 Under Local Rule 5(g), a pleading cannot be sealed without a specific showing of  
22 grounds overcoming the "strong presumption in favor of public access." Microsoft  
23 properly provided in its motion the grounds that it felt were appropriate. If  
24 Immersion wishes to provide alternative grounds, it is free to do so.



1 Finally, Immersion's objection to Microsoft's proposed order is misplaced.  
2 The order makes no ruling on whether or not the Sony/Immersion agreement is a  
3 "settlement" -- the ultimate issue in this case. Indeed, the order proposed by  
4 Immersion is strikingly similar to that proposed by Microsoft. Microsoft consents to  
5 either form of order.


