 25 wholesale through Internet.

 14 Q. Who owns MyLeather.com?
 15 A. Helmet Venture, Inc.
 16 Q. Are you an officer of Helmet Venture, Inc.?
 17 A. Yes.
 18 Q. And where is Helmet Venture, Inc.,
 19 incorporated?
 20 A. State of California.
 21 Q. Who are the other officers?
 22 A. I believe I'm the only officer.
 23 Q. Does Helmet Venture, Inc., have articles of
 24 incorporation?
 25 A. I believe so, yes.
