Defendant OfficeMax Incorporated ("OfficeMax") respectfully joins in Defendants Google Inc. and YouTube, LLC's Reply in Support of Motion to Dismiss for Failure to State a Claim Upon Which Relief Can Be Granted Pursuant to Fed. R. Civ. P. 12(b)(6) ("Google's Reply") (Docket No. 130). As discussed in Google's Reply, Plaintiff Interval Licensing LLC's claims against all defendants – including OfficeMax – fail to meet the pleading requirements of Fed. R. Civ. P. 8 as defined by the Supreme Court in *Ashcroft v. Iqbal*, 129 S. Ct. 1937 (2009) and *Bell Atlantic v. Twombly*, 550 U.S. 544 (2007). Accordingly, OfficeMax joins Google's Reply, and respectfully asks this Court to dismiss Plaintiff's complaint.
