Interval Licensing LLC's allegations of infringement of U.S. Patent No. 6,263,507 ("the '507 patent) against eBay Inc., Netflix, Inc., Office Depot, Inc., and Staples, Inc. are substantively identical to the allegations it has asserted against Google Inc. and YouTube, LLC. *Compare* Complaint for Patent Infringement (Docket No. 1) ¶ 24 (Google Inc.) and ¶ 30 (YouTube, LLC) *with id.,* ¶ 23 (eBay Inc.); ¶ 25 (Netflix, Inc.); ¶ 26 (Office Depot, Inc.); and ¶ 28 (Staples, Inc.). Accordingly, the allegations are deficient for the same reasons set forth in Google Inc. and YouTube, LLC's Motion to Dismiss.

Interval Licensing LLC's allegations of infringement of U.S. Patent No. 6,757,682 ("the '682 patent) against eBay Inc., Netflix, Inc., Office Depot, Inc., and Staples, Inc. are substantively identical to the allegations it has asserted against Google Inc. and YouTube, LLC. *Compare* Complaint for Patent Infringement (Docket No. 1) ¶ 49 (Google Inc.) and ¶ 55 (YouTube, LLC) *with id.,* ¶ 47 (eBay Inc.); ¶ 50 (Netflix, Inc.); ¶ 51 (Office Depot, Inc.); and ¶ 53 (Staples, Inc.). Accordingly, the allegations are deficient for the same reasons as those set forth in Google Inc. and YouTube, LLC's Motion to Dismiss.
