
1 it appearing to this Court that the proposed modified payment schedule is
2 appropriate; it is hereby

3 ORDERED that Defendant-Respondent Sampson will make a payment to the
4 appointed Independent Fiduciary of \$1,000 by March 30, 2018 in lieu of repaying
5 payments due to date; and it is further

6 ORDERED that Defendant-Respondent Sampson will make quarterly
7 payments in the amount of \$4,000 starting on April 15, 2018 toward his obligation to
8 the Plan and under the Consent Judgment, and will continue to make quarterly
9 payments due on the 15th of July, October, January and April until the Plan is wholly
10 compensated; and it is further

11 ORDERED that Defendant-Respondent Sampson will provide timely
12 information about changes to his financial circumstances to the Secretary of Labor to
13 accelerate the resolution of his obligation to the Plan; and will submit a financial
14 affidavit to the Secretary of Labor at least annually at the beginning of each calendar
15 year.
