 Distribution Order").

4. The Bankruptcy Distribution Order is a condition precedent to the settlementbeing finalized.

5. The parties anticipate filing a motion seeking the Bankruptcy Distribution Order
before year-end to be heard by the Bankruptcy Court in January 2012.
