Washington, with the Honorable Terrence Lukens (Ret.) serving as mediator. Judge Lukens has mediated numerous TCPA cases involving counsel for both parties. The parties subsequently finalized their settlement negotiations, and McClintic moved the Court for preliminary settlement approval on August 8, 2011. Although DME was not a party to this action, DME actively participated in the mediation and provided data necessary for the parties to formulate a fair settlement.

- 4. McLaren initiated an action in the District of Oregon, Cause No. 11-cv-00810 MO nearly two and a half months after the *McClintic* case began.
