1. I make all of the following statements of my own personal knowledge.
2. I understand that I seek to be the class representative in this case. I believe very

strongly in seeking redress for myself and others who are the victims of conduct like that of the Defendant. I am not bringing this action to obtain money but to obtain an order from the Court forbidding Defendant from making robo-calls. I hope such an order would affect other businesses that do this sort of thing.

3. I understand that I represent the interests of all class members who have been affected by the challenged conduct.

4 and should confer with class counsel at any time it is appropriate. Counsel will keep me  
5 informed of all events in the litigation.


6 5 I understand I should vigorously prosecute this litigation. I will authorize my  
7 attorneys to do what is necessary to prosecute this case successfully on behalf of the class. I have  
8 hired attorneys who are experienced in class actions and whom I trust.

10 6. I have not been promised any special treatment beyond the treatment  
11 which may be awarded to other class members. I do understand that if we are successful,  
12 my attorneys will probably ask the Court to award me additional compensation for the  
13 extra time and effort I expend as a class representative and for having the initiative and  
14 desire to challenge the Defendants' conduct. My attorneys have not guaranteed that the  
15 Court will approve any extra payment for me, nor is the potential of such extra payment  
16 the basis for my bringing this action.

18 7. In August 2009, I received a pre-recorded message from Domino's Pizza. I  
19 have not requested such messages and did not consent to them.
