- 2.2 From about January 7, 2007, Plaintiff was employed by Safeway as a Second Assistant Store Manager at Safeway's Coal Creek Parkway store (the "Store").
- 2.3 On or about June 2008, Safeway demoted Plaintiff from her role as manager at the Store and transferred her to the Fairwood Store.
- 2.4 The reason given by Safeway for Plaintiff's demotion was that "people as old and frail as [Plaintiff] probably shouldn't be working as a manager."
 - 2.5 On or about October 18, 2008, Safeway discharged Plaintiff from employment.
 - 2.6 Plaintiff was injured while working for Safeway on July 16, 2007.
 - 2.7 Plaintiff filed a workers' compensation claim after her injury.
 - 2.8 Plaintiff performed excellent work at all times prior to and after her injury.
- 2.9 At the time of discharge, Plaintiff was performing all of the essential functions of the job and was capable of performing all the essential functions of the job, with the accommodation of light duty/modified work.
 - 2.10 Safeway denied Plaintiff light duty/modified work after about May 2008.
- 2.11 Plaintiff's age, sex and disability status were not bona fide occupational qualifications for the job.
- 2.12 Males, persons without disabilities, and employees under the age of 40, were not discharged or demoted for similar reasons.
- 2.13 Plaintiff was replaced by a male and/or employees under the age of 40, employees who did not have a disability or were significantly younger than plaintiff.
- 2.14 During plaintiff's employment, Safeway maintained and distributed to employees an employee handbook, which contained a policy prohibiting discrimination in the workplace.
- 2.15 Plaintiff received a copy of Safeway's handbook, read the policy and relied upon the policy during her employment and in not seeking employment elsewhere.
- 2.16 Safeway demanded that employees comply with the work rules and policies set out in the employee handbook.

2.17 Safeway failed to comply with its employment policy with regard to the Plaintiff's demotion, failure to provide accommodations after May 2008, and eventual discharge from employment, when she would have otherwise been able to work with her disability.

III. CLAIMS AND CAUSES OF ACTION

A. CLAIM FOR DISCRIMINATION

- 3.1 Safeway discharged Plaintiff from employment because of Plaintiff's age, sex, and physical limitation in violation of the Washington Law Against Discrimination, RCW 49.60.180.
 - B. CLAIM FOR WRONGFUL TERMINATION--BREACH OF EMPLOYMENT CONTRACT AND/OR EMPLOYMENT POLICY
- 3.2 Safeway's policy contained in its policy manual constituted a promise of specific treatment in the case of termination for cause or failure to reasonably accommodate.
- 3.3 Safeway's policy manual constituted an implied contract of employment, such that Plaintiff's employment could only be terminated for good cause and only in conformity with the provisions of Safeway's policy manual.
- 3.4 Safeway breached the specific promises of treatment set out in its policy and breached its implied contract of employment with Plaintiff, when defendant demoted and terminated Plaintiff's employment without good cause or without accommodation.

C. CLAIM FOR FAILURE TO ACCOMMODATE

- 3.5 Safeway had a duty to engage in an interactive process of accommodating Plaintiff's workplace-induced physical limitation.
- 3.6 Safeway failed to accommodate Plaintiff's physical limitation in violation of the Washington Law Against Discrimination, RCW 49.60.180, when Safeway demoted and terminated Plaintiff's employment without providing an alternative for her to maintain her employment.

D. CLAIM FOR RETALIATION

3.7 Safeway retaliated against Plaintiff for filing a workers' compensation claim and for requesting a workplace accommodation.

THE PARTIES ARE RESPONSIBLE FOR KNOWING AND COMPLYING WITH ALL DEADLINES IMPOSED BY THE COURT'S LOCAL CIVIL RULES.

A. Joint Confirmation regarding Trial Readiness Report:

No later than twenty one (21) days before the trial date, parties shall complete and file (with a copy to the assigned judge) a joint confirmation report setting forth whether a jury demand has been filed, the expected duration of the trial, whether a settlement conference has been held, and special problems and needs (e.g. interpreters, equipment, etc.).

The form is available at http://www.kingcounty.gov/courts/superiorcourt.aspx . If parties wish to request a CR 16 conference, they must contact the assigned court. Plaintiff's/petitioner's counsel is responsible for contacting the other parties regarding said report.

B. Settlement/Mediation/ADR

- a. Forty five (45) days before the trial date, counsel for plaintiff/petitioner shall submit a written settlement demand. Ten (10) days after receiving plaintiff's/petitioner's written demand, counsel for defendant/respondent shall respond (with a counter offer, if appropriate).
- b. Twenty eight (28) days before the trial date, a Settlement/Mediation/ADR conference shall have been held. FAILURE TO COMPLY WITH THIS SETTLEMENT CONFERENCE REQUIREMENT MAY RESULT IN SANCTIONS.
- **C. Trial:** Trial is scheduled for 9:00 a.m. on the date on the case schedule or as soon thereafter as convened by the court. The Friday before trial, the parties should access the King County Superior Cour website http://www.kingcounty.gov/courts/superiorcourt.aspx to confirm trial judge assignment. Information can also be obtained by calling (206) 205-5984.

MOTIONS PROCEDURES

A. Noting of Motions

Dispositive Motions: All summary judgment or other dispositive motions will be heard with oral argument before the assigned judge. The moving party must arrange with the hearing judge a date and time for the hearing, consistent with the court rules. Local Civil Rule 7 and Local Civil Rule 56 govern procedures for summary judgment or other motions that dispose of the case in whole or in part. All such motions must be noted for a date by which the ruling is requested; this date must likewise conform to the applicable notice requirements. Rather than noting a time of day, the Note for Motion should state "Without Oral Argument." Local Civil Rule 7 governs these motions, which include discovery motions. The local civil rules can be found at http://www.kingcounty.gov/courts/superiorcourt/civil.aspx.

Motions in Family Law Cases not involving children: Discovery motions to compel, motions in limine, motions relating to trial dates and motions to vacate judgments/dismissals shall be brought before the assigned judge. All other motions should be noted and heard on the Family Law Motions calendar. Local Civil Rule 7 and King County Family Law Local Rules govern these procedures. The local rules can be found at http://www.kingcounty.gov/courts/superiorcourt/civil.aspx.

Emergency Motions: Under the court's local civil rules, emergency motions will be allowed only upon entry of an Order Shortening Time. However, emergency discovery disputes may be addressed by telephone call and without written motion, if the judge approves.

Original Proposed Order: Each of the parties must include an original proposed order granting requested relief with the working copy materials submitted on any motion. Do not file the original of the proposed order with the Clerk of the Court. Should any party desire a copy of the order as signed and filed by the judge, a pre-addressed, stamped envelope shall accompany the proposed order.

Presentation of Orders: All orders, agreed or otherwise, must be presented to the assigned judge. If that judge is absent, contact the assigned court for further instructions. If another judge enters an order on the case, counsel is responsible for providing the assigned judge with a copy.

Proposed orders finalizing settlement and/or dismissal by agreement of all parties shall be presented to the assigned judge or in the Ex Parte Department. Formal proof in Family Law cases must be scheduled before the assigned judge by contacting the bailiff, or formal proof may be entered in the Ex Parte Department. If final order and/or formal proof are entered in the Ex Parte Department, counsel is responsible for providing the assigned judge with a copy.
