Thomas S. Zilly, United States District Judge:

13 (1) On or before November 27, 2017, plaintiffs shall SHOW CAUSE why
14 defendants Does 1-25 should not be dismissed with prejudice for failure to prosecute.
15 *See* Fed. R. Civ. P. 4(m), 10(a), & 41(b); *see also Ouma v. Clackamas Cnty.*, 663 Fed.
App'x 544, 545 (9th Cir. 2016); *Gillespie v. Civiletti*, 629 F.2d 637, 642-43 (9th Cir.
1980).

16 (2) Having reviewed the parties' Joint Status Report, docket no. 304, the Court
17 SETS the following dates and deadlines:
