15 On December 4, 2019, the court ordered the parties to show cause whether
16 Defendant City of Seattle (“the City”) failed to maintain full and effective compliance
17 with the Consent Decree.¹ (OSC (Dkt. # 504).) Based on a stipulation of the parties, the
18 court agreed to set the deadline for (1) the City’s response to the order to cause on
19 December 17, 2018, (2) Plaintiff United States of America’s (“the Government”)

1 response on January 9, 2019, and (3) the City’s reply on January 16, 2019. (12/11/18
2 Order (Dkt. # 507) at 1.)

3 On December 21, 2018, the appropriations act that had been funding the
4 Department of Justice (“DOJ”) expired and appropriations to DOJ lapsed. (*See* DOJ
5 Mot. (Dkt. # 514) at 1.) Accordingly, the Government requested a stay of all pending
6 deadlines in this case until Congress and the President restored appropriations to DOJ.
7 (*See generally id.*) On January 2, 2019, the court granted the motion and extended the
8 deadlines for the parties’ responses to the order to show cause “commensurate with the
9 duration of the lapse in appropriations.” (1/2/19 Order (Dkt. # 517) at 1.)

10 On Friday, January 25, 2019, President Donald Trump signed into law House Joint
11 Resolution 28, the “Further Additional Continuing Appropriations Act, 2019,” which
12 included a short-term continuing resolution that provides fiscal year 2019 appropriations
13 through February 15, 2019. Because DOJ’s funding is restored, the court lifts its stay of
14 this matter.

15 The lapse in appropriations lasted for a total of 35 days. Accordingly, based on its
16 January 2, 2019, order extending the deadlines “commensurate with the duration of the
17 lapse in appropriations,” the court resets the following deadlines: (1) the Government’s
18 response to the court’s order to show cause is due on Wednesday, February 13, 2019, and
19 (2) the City’s reply is due on Wednesday, February 20, 2019. (*See* 1/2/19 Order at 1.)


