BURWELL, in her official 15 capacity as Secretary, United States 16 Department of Health and Human Services, 17 Defendant. 18 19 Come now the Plaintiffs, University of Washington, d/b/a University of Washington 20 Medical Center and Harborview Medical Center (the "Hospitals"), and file this Motion of 21 Voluntary Dismissal pursuant to Fed. R. Civ. P. 41(a)(2), together with a Proposed Order. 22 This case turns on a single legal question: whether in the context of applying a 23 formula to calculate a portion of the Hospital's Medicare reimbursement, the Secretary 24 properly excluded from the adjustment pertaining to the Hospital's indirect graduate medical 25 education ("IME"), the time spent by Hospital residents conducting research that was 26 unrelated to any particular patient's care. This exact issue has been addressed in two other 27

cases in which the court of appeals ruled in favor of the Secretary. Rush University Medical

1	Center v. Burwell, 763 F.3d 754 (7th Cir. 2014); Henry Ford Health System v. Department of
2	Health and Human Services, 654 F.3d 660 (6th Cir. 2011). In light of these decisions, the
3	Hospitals have decided not to pursue this issue further. Accordingly, the Hospitals now
4	move to voluntarily dismiss this case without prejudice and without costs to any party.
