No. 623) and the Amended Settlement Agreement (Dkt. 599-1). 21 IT IS HEREBY ORDERED that the judgment entered on December 18, 2018, shall be 22 amended to exclude those fines calculated under the Court's prior contempt Order relating to the 23 inpatient portion of the class (Dkt. 289). The Department shall instead be ordered to pay 24 \$378,750, the total fines calculated for that period for the in-jail portion of the class. 25 26
