8 In its July 6, 2018 Order on Motions to Seal (ECF No. 238) (the “Order”), the Court  
9  
10 granted in part and denied in part the Motion to Seal filed by Defendants (ECF No. 235). The  
11  
12 Court ordered that Plaintiff file new unsealed or redacted versions of certain documents  
13  
14 identified in the Order no later than twenty-one days from the date of the Order, or by July 27,

19 As required by the Order, the parties held a meet-and-confer and worked cooperatively to

30 In the interest of continuing these meaningful confidential settlement negotiations, the

32 parties respectfully request that the July 27, 2018 deadline, by which the Court ordered Plaintiff

34 to file new unsealed or redacted versions of certain documents, be extended by one week to

36 August 3, 2018.
