19 Pursuant to Fed. R. Civ. P. 6(b)(1)(B), Defendants Monsanto Company, Solutia Inc., and  
20 Pharmacia Corporation ("Defendants") sought an extension of the deadline for refiling responses in  
21 opposition to the City's Motions to Exclude Defendants' expert witnesses Marc Rogoff (Dkt. 601)  
22 and John Woodyard (Dkt. 621), which were not filed due to excusable neglect. The City did not  
23 oppose this motion.

24 Having considered Defendants' motion, the Court concludes that Defendants have satisfied  
25 their burden under Rule 6(b)(1)(B) of demonstrating that their neglect was excusable.

26 THEREFORE, it is hereby ORDERED that Defendants' Motion for an extension of the  
27 deadline for refiling their refiling responses in opposition to the City's Motions to Exclude

1 Defendants' expert witnesses Marc Rogoff (Dkt. 601) and John Woodyard (Dkt. 621), including the  
2 opposition briefs and the supporting declarations of Hansen and Goutman, is GRANTED.
