1 **TO THE COURT, ALL PARTIES AND THEIR COUNSEL OF RECORD:**

2 1. In accordance with the Court's October 24, 2017 Order Preliminarily Approving
3 Proposed Settlement and Providing for Notice (ECF No. 107), Lead Plaintiff's Motion for Final
4 Approval of the Proposed Settlement, the Plan of Allocation and Lead Counsel's Request for
5 Attorneys' Fees and Expenses is due to be filed by December 28, 2017.

6 2. Lead Plaintiff seeks leave to file on December 28, 2017, one motion, not
