15 **THIS MATTER** comes before the Court on counsel's "Petition for Approval of Minor  
16 Settlement and for Disbursal of Settlement Proceeds." Dkt. # 62. Having reviewed the records and  
17 files herein and being fully advised in the premises, does make and enter the following:

18 **FINDINGS**

19 1.1 The court finds that the Settlement Guardian ad Litem, Patrick Trudell, performed  
20 the investigation, evaluation and the report properly.

21 1.2 The court also finds that the proposed settlement of the minor's claims arising out of  
22 an October 4, 2014 cut to her arm and the resulting scar is fair and equitable and in the best interests  
of the minor and should be approved by the court.

23 **ORDERS**

24 **ORDERED, ADJUDGED and DECREED** that

25 2.1 The proposed settlements as set forth in the Report of Patrick Trudell on  
26 Adequacy of Minor's Settlement, is approved;

1 2.2 Scott A. McDonald shall deposit the settlement check from the defendant, or its  
2 insurance company, in his trust account and issue checks from his trust account  
3 made payable as follows\*:

16 \*Patrick Trudell shall also be paid for his attorney's fees from the defendant directly  
17 in the amount of \$1,000.00.

18 2.3 That Scott A. McDonald shall file a receipt for the \$11,056.56 deposit with the  
19 Clerk of the Court within 30 days of this order.

20 2.4 That Scott A. McDonald, the minor's attorney, and/or the minor's father and/or the  
21 SGAL herein, are hereby authorized to execute the necessary documents to  
22 effectuate the settlement with the defendant consistent with this order.

23 2.5 That after the minor turns 18 years old on the bank shall release the funds in the  
24 blocked account to the minor.
