ORDER GRANTING DEFENDANTS GOLFBESTBUY INC. AND JONATHAN WANG’S REQUEST TO TRANSFER TO THE UNITED STATES DISTRICT COURT FOR THE NORTHERN DISTRICT OF CALIFORNIA

This matter came before the Court on Defendants GolfBestBuy Inc. and Jonathan Wang’s (collectively “Defendants”) Second Motion to Dismiss or, in the alternative, request to transfer this case to the United States District Court for the Northern District of California under 28 U.S.C. § 1404(a) (Dkt. ## 24, 45). Having reviewed the Motion and request, all papers filed in support of and in response thereto, and having heard the argument of counsel, the Court makes the following findings:

1. Three cases with factual issues, parties, and claims that overlap with the factual issues, parties, and claims in this matter have been consolidated in the United States District

1 Court for the Northern District of California in Case No. 3:17-cv-00898, *Wang v. Golf Tailor,*
2 *LLC.*

3 2. This matter might have originally been brought in the United States District Court
4 for the Northern District of California as Defendants are residents of California and are located
5 in that district.

6 3. The public and private interests that must be considered in determining whether to
7 transfer this matter under 28 U.S.C. § 1404(a) weigh in favor of transferring this case to the
8 United States District Court for the Northern District of California.


9 Therefore, being fully advised in the premises, now, it is ORDERED that:

10 A. For the convenience of the parties and witnesses, in the interest of justice,
11 Defendants' request to transfer this case to the United States District Court for the Northern
12 District of California pursuant to 28 U.S.C. § 1404(a) is GRANTED; and

13 B. This case is TRANSFERRED to the United States District Court for the Northern
14 District of California.

15 C. This transfer expressly includes defendant Kingstar Corporation, a/k/a Dongguan
16 City Huanda Sports Equipment Co. Ltd., a Chinese corporation ("Kingstar"). If and when
17 service on Kingstar is completed, Kingstar shall proceed in the United States District Court for
18 the Northern District of California as if this case had originally been filed in that court. Nothing
19 in this Order is intended to require Golf Tailor to restart Hague Convention service on Kingstar.
