**STIPULATED JOINT MOTION AND  
ORDER FOR CONTINUANCE OF  
TRIAL DATE AND RELATED  
DEADLINES**

**MOTION**

Counsel for all Parties (Plaintiff Evergreen Estates Condominium Association and Defendants Admiral Insurance Company, Associated International Insurance Company (“AIIC”) and Markel Insurance Company) submit this stipulated motion for a two-and-a-half-month continuance of the trial date and related dates as described below. The parties’ joint motion is based on LCR 10(g) and LCR 16(b)(5). The motion is supported by the declaration of attorney Daniel Houser. Mr. Houser has conferred with counsel for the other

1 parties—Mr. McCormack for AIIC and Markel, and Mr. Bentson for Admiral—and Mr.  
2 Houser is submitting this motion and declaration at the request of Mr. McCormack and Mr.  
3 Bentson.

4 **REASONS JUSTIFYING PROPOSED CHANGE**

5 Mr. Houser, Mr. Bentson, and Mr. McCormack are opposing counsel in several  
6 pending cases. Mr. McCormack previously agreed to continue the trial of this action from  
7 September 2017 to January 2018 as a professional courtesy to Messrs. Houser and Bentson  
8 to allow for the trial of *Eagle Harbour Condo Association v. Allstate, et. al.*, Cause No.:  
9 3:15-CV-05312-RBL.

10 Due to conflicts with other pending cases the attorneys have conferred about a second  
11 trial continuance. Along with their clients, they are in unanimous agreement that a two-and-  
12 a-half month continuance of the trial date in this matter, along with a concomitant  
13 rescheduling of pending deadlines, is an appropriate solution if this Court agrees. What the  
14 parties specifically request is as follows:
