5 IT IS THEREFORE ORDERED as follows:

6 That the Garnishee, Noll/NorWesCo, LLC, shall pay to the United States
7 District Court for the Western District of Washington, the non-exempt
8 earnings payable to Defendant/Judgment Debtor Bernard Gurr, upon each
9 period of time when Defendant/Judgment Debtor Gurr is entitled to receive
10 such funds, and shall continue said payments, if any, until Defendant/
11 Judgment Debtor Gurr's debt is paid in full or until Defendant/Judgment
12 Debtor is no longer an active employee of Garnishee and the Garnishee no
13 longer has possession, custody, or control of any funds due and owing to the
14 Defendant/Judgment Debtor or until further order of this Court. This
15 includes all monies required to be previously withheld by the Garnishee that
16 the Garnishee has not already paid to the Court, in accordance with the Writ
17 of Continuing Garnishment;

18 That such payments shall be applied to Defendant/Judgment Debtor
19 Gurr's outstanding restitution obligation, by the United States District Court
20 for the Western District of Washington; and

21 That the payments shall be made out to the United States District
22 Court, Western District of Washington, referencing Case Nos. 2:08-CR-00411-
23 JLR-1 and 2:16-MC-00179-RSL, and to deliver such payment either
24 personally or by First Class Mail to:
