19 COMES NOW RICK SATCHER and moves the court to join as an interested party of
20 interest or intervene in the above Identified case filed in the Western District of Washington as
21 a matter of right, as described in the Federal Rules of Civil Procedures, Rule 17(a) Real Party in
22 Interest or Rule24 (a) Intervention as a matter of Right.

23 I RICK SATCHER swear under the penalty of perjury of the laws of the United States the
24 following is true and correct to the best of my knowledge.

25 I am a citizen of the public trust known as the State of Washington who has been
26 damaged by Washington State Attorney General Robert Ferguson's actions involved herein.

27 I am requesting a change of jurisdiction and venue for the reasons I cite below, and
28 because the Federal Judges in the Ninth Circuit are motivated by their conflict of interests to be
29 biased and prejudice, and it will be impossible to obtain a fair trial in the matters I present
30 herein in the jurisdiction of the Ninth Circuit Court of Appeals.

31 I am an individual that has been seriously damaged by organized criminal actions of
32 public officials holding public office in the Ninth Circuit Court Of Appeals, the U.S. Federal
33 District Courts in Washington and Oregon and the State Courts in Washington.

1 I can prove in court with substantial evidence the corruption in the courts of Lewis
2 County and the deliberate cover up provided by the higher courts, Attorney General Robert
3 Ferguson and Governor Jay Inslee. This corruption covers murder, the theft of the retirement
4 savings of the elderly, and the theft of real property belonging to the elderly and myself.

5 John Meyer was my attorney in child court for my oldest son. He was 20 and going to
6 college taking one class in which he never showed up for. I was required to pay full child
7 support by Judge Hall. At this time I was the only driver for my gravel business. I was financially
8 unable to pay child support so Judge Hall took my license away making it impossible to make
9 any money. I went to Cowlitz County with a complaint against Lewis County and Cowlitz County
10 ordered that Judge Hall should give my license back. Judge Hall refused to do so even though
11 Cowlitz County was the acting county in the case. John Meyer knew all of this and did nothing
12 to stop this crime. By doing so he damaged me and my family.

13 William Hillier has been my attorney my whole life which includes but not limited to
14 logging contracts, purchase/selling of land, and the brucellosis case involving the FBI. I have
15 gone to court against him in Federal Court, Federal investigations, Supreme Court, Superior
16 Court, and in court in San Francisco District #9. William Hillier perjured himself by saying that he
17 has never represented Rick Satcher which is a federal offence. He also falsified a will by not
18 following my grandfather's wishes- another federal offense. William Hillier did not report my
19 grandfather's death for over two years. I believe he did it to cash his social security checks and
20 his stocks and bonds taken from the safe at the bank while he was temperately in charge of the
21 estate.

22 William Hillier also participated in the scheme to take over my grandfather's estate. I
23 also believe that he helped Vanderstoop, Kelly and Blinks to cash stocks and bonds in the Jerry
24 Moore murder. My grandfather had worked for Tomson Logging since he was fourteen years
25 old. His name was on several stocks and bonds that were held by Jerry Moore. My grandfather
26 also had private bonds that he had bought due to timber and cattle sales. My grandfather has
27 owned everything his entire life and did very well. He stored smaller amounts in stocks and
28 bonds, an 86oz gold bar, along with other not as large pieces of jewelry from the early 1800's in
29 his personal safe. He owned 140 acres of all fenced land, two houses, two shops, shop

1 equipment, tractors, and much more. Some of the items included in his safety deposit box at
2 Security State Bank were stocks and bonds from Jerry Moore, jewelry, and some other gold and
3 silver bars. He also had hundreds of thousands of dollars -in Morgan and Stanley. Everything
4 that my grandfather had was taken over by William Hillier under the pretense that he did not
5 have enough money to provide care of himself which was a lie. His life estate wish was to come
6 live with my wife and I when he could not care for himself anymore. I was more than happy to
7 do this. All this evidence was ignored by the court house for Mr. Hillier. He was even allowed to
8 use his pervious law partner as a Judge to throw out all the evidence in a case against him. I
9 believe that the court house officials knew that William Hillier and Judge Hall had been partners
10 in law. These people were allowed to destroy my life with the help of the court house.

11 Scott Blinks and his Law Firm have been my attorneys previously and are now against
12 me, which is a conflict of interest. They were fully informed about this by my first lawyer Dennis
13 Ott who was ran off by Judge Hall. I believe he did this so that he could cash in the socks and
14 bonds that were in my grandfather's name from Jerry Moore. He buried my grandfather still
15 had not reported his death to Olympia-after two years. I believe the entire time he was cashing
16 in his social security checks. Mr. Blinks was also involved in a case of malpractice where he had
17 to pay 3 million dollars in damages'. In that case he and another lawyer sent over 17 letters in
18 an 11 year period back and forth asking for the same information and which was denied each
19 time. The family finally hired another lawyer which resulted in the malpractice case against
20 Scott Blinks. I believe the Lewis County Court House is a criminal organization whose only
21 function seems to be to steal assets from the next generation. Mr. Blinks has also falsified court
22 house documents when he checked out the case for three days. He had put his Lis pen dens in
23 front of the one that I had already filed. My grandfather and I had paid the taxes and did a title
24 change that same day. If he had his in Lis pen dens in we would not have been able to do so.
25 Mr. Blinks also perjured himself in Superior and Federal Court by saying he had never
26 represented me.

27 I have sent in more than enough evidence to show a conflict of interest and criminal
28 activity to the Washington State Bar, with no results. Mr. Blinks has had to pay 3 million dollars
29 in damages in a malpractice case in another estate case which was also reported to the

1 Washington State Bar and again nothing was done. After finding out Mr. Vanderstoop was the
2 president of the Washington State Bar I believe that they use the Washington State Bar to cover
3 up criminal activity involving estates. During the time that Mr. Vanderstoop was president the
4 Jerry Moore estate was taken over even though there was no complaint made. As far as I know
5 all of Mr. Moore's money was missing from his estate including money from stocks and bonds
6 that he ran for companies and private parties. One of those private parties was my grandfather.
7 Mr. Moore would come to my grandparents' house four or five times a year and talk about
8 retirement accounts and at times my grandfather would purchase more stocks and bonds from
9 him.

10 During my complaints to the Washington State Bar it became clear to me that Debra
11 Slator, officer of the Washington State Bar was obstructing justice with a government office. In
12 phone conversations and letters she always found no conflicts of interest even though I had
13 sent her an overwhelming amount of evidence showing it was going on. I have sent several
14 letters asking for her to be removed from cases and she refused to do so and would keep
15 reappearing in my cases. I have even sent a letter to the president of the Washington State Bar
16 asking for Debra Slator to be removed from the case and for records on the Jerry Moore audit.
17 When I received a response back it was from Debra Slator refusing my records request and no
18 mention of her removal. It makes me wonder how much of my evidence was actually making it
19 to the Washington State Disciplinary Board about grievances on William Hillier, Scott Blinks, and
20 Debra Slator. I do not believe that any normal human being would have come to the
21 conclusions that Debra Slator did seeing all the evidence that I had sent her. I also believe that
22 Debra Slator is a part of the Jerry Moore murder cover up.

23 Pilot Mike Mezmore ran for congress just after this plane crash took place. He was my
24 instructor and a very good pilot. No mistakes were made with his procedures. This airplane was
25 in perfect condition prior to my engine failures. I had three engine failures within a months'
26 time. Two of the engine failures were because of an unknown substance in the carburetor right
27 after being serviced and one failure was because of a wire that was cut that was located inside
28 of a stainless steel tube. No planes have this many issues unless someone is intentionally
29 making them have them. I believe someone was tampering with my plane. Two people were

1 killed as a result of the tampering that was done to my plane. The only time my plane had
2 mechanical issues was when it had been exposed to the public. It was normally kept in an
3 enclosed hanger but had been left outside each time the plane had these issues. When the FAA
4 looked into the crash we' did not know there could be a possibility of tampering until another
5 attempt was made on our lives on our way back from our boat. A car came up really close
6 behind us and when it passed us it came so close that we almost ran off the road. At first I
7 thought that they must have been in a really big hurry until they went to the end of
8 straightaway turned around and came back at us in our lane full blast. I was able to swerve into
9 the ditch and came back out just missing the car. This was just after I reopened the case at the
10 Washington State Bar along with other investigations.

11 It is of the utmost importance that we keep our borders secure, and that we exercise
12 control over who we allow to enter. In our norther boarder great care is taken to screen all
13 individuals entering the United States of America from Canada. However our southern border is
14 nearly wide open and anyone can cross into the United States with little or no effort. At our
15 airports the president is attempting to exercise the legitimate control required by our
16 Constitution. Washington State Attorney General Robert Ferguson, solely for personal political
17 gain has attempted to thwart President Trump from doing his duty. This leaves all residents
18 within our borders vulnerable to violent attack and crime. Not only is president Trump being
19 blocked but national security is also being compromised, and that is an act of treason.

20 The plaintiff of this case, Washington State Attorney General Robert Ferguson directly
21 engaged in the cover up of crimes against the elderly, as such he and his accomplices are guilty
22 of a class C felony. In accordance with State law I am requiring Washington State Attorney
23 General Robert W. Ferguson, Governor Jay Inslee and their accomplices in the corrupt judicial
24 branch of Washington State including but not limited to our Supreme County Justices to vacate
25 their offices immediately.

26 The corruption I have run into exposes depth of corruption in the State of Washington,
27 which is rooted deep in the Federal District courts and the Ninth Circuit Court of Appeals, and
28 as such I will never be able to fairly and justly address the property crimes I have been

1 subjected to in the jurisdiction of the judicial branch of Washington State or the Jurisdiction of
2 the Ninth Circuit Court of Appeals.

3 Public officials including Robert Ferguson and top ranking judicial branch members have
4 instigated, condoned and supported these property crimes against me to steal from me my
5 property and life. I will address and expose the organized crimes and criminal activities of top
6 ranking public officials in Washington State and the Federal courts in Washington and the
7 Districts in the Ninth Circuit Court of Appeals.

8 I will provide evidence showing court officials of Washington State have a history of
9 engaging in public corruption, for financial gain and to maintain control of the government in
10 Washington State and conceal their involvement in public corruption and subversive attacks on
11 our constitutional form of government. I will provide evidence showing that the U.S. Federal
12 District Courts in Washington have assisted and are accomplices to corrupt Washington officials
13 organized criminal actions (RICO).

14 I will provide evidence showing that corrupt public officials in Washington have allowed
15 dead people to vote and collect Social Security Benefits to support their organized crimes,
16 corruption, subversive activities to overthrow the separate branches of government, and force
17 their socialist, communistic, oligarchy agendas onto the people.

18 I will provide evidence showing this case filed by Attorney General Robert Ferguson and
19 Governor Jay Inslee was filed to insure they and their accomplices would get elected to conceal
20 organized crimes and corrupt activities and protect their criminal and corrupt activities
21 involving election fraud and voter crimes. I will provide testimony and evidence to show the
22 intent of this lawsuit is to allow illegal aliens to vote for them and their accomplices.

23 I will provide evidence showing corrupt public officials in Washington and Oregon
24 purchased votes by provided pecuniary benefits, special privileges and immunities to influence
25 voters to vote for them.

26 I will provide evidence showing that Washington State Attorney General Robert
27 Ferguson and Washington State attorney Governor Jay Inslee and their accomplices stole more
28 than 6 million dollars from my family in an attempt to prevent me from being financially able to
29 expose the organized criminal activities of public officials in Washington State.

1 I will provide evidence showing the judicial branch of Washington State has overthrown
2 the Legislative and Executive branches of Washington State to obtain power, money and
3 "Nobility" for their fellow members of the judicial branch.

4 I will provide evidence showing the Judicial Branch of Washington State have become
5 predators who are preying on the lives, liberties and properties of the producers and beneficial
6 parasites of Washington State.

7 I will provide evidence showing where the predators and detrimental parasites of
8 Washington, Oregon and the federal government are soliciting pecuniary benefits, special
9 privileges and immunities from the beneficial parasites of Washington and the Federal
10 Government to create Nobility and provide money and power to them and their accomplices.

11 JURSDICTION

12 Jurisdiction is proper outside of the Ninth Circuit because the Judges of the Ninth Circuit
13 have organized with the state judges to take individual rights under the guise "it is in the
14 people's best interests" and as such they are corruptly attacking our constitutions are creating
15 the problems and should be defendants to the action and removed from their official positions.

16 COUNTER CLAIM FOR DAMAGES

17 The foregoing and following is to be considered a **claim for damages**. I intend to
18 leverage the official bonds and malpractice insurance policies of the public officials involved
19 and their accomplices for organizing to defraud my family and the taking of my personal
20 property under the color of law. I will identify additional causes of action and defendants to my
21 counter claim when time allows me to proceed with an official **complaint for damages**.

- 22 1. RICO Fraud - A jury will determine I was defrauded by organized criminal actions of
23 the plaintiff and others by more than 3 million dollars, and will award me triple
24 damages.
- 25 2. RICO Organized Crime – A jury will determine the plaintiff worked with others to
26 instigate and use the courts to take my property and the property of others and will
27 award me, my family, Next friends, and political supporters substantial damages for
28 economic, emotional, social, public humiliation, public ridicule, public

1 embarrassment, physical distress, physiological pain, and unconstitutional and
2 criminal "takings" of life liberty and property.

- 3 3. A complete tort claim identifying constitutional violations @ \$10,000.00 per
4 violation and identifying other defendants of counter claim will be forthcoming, as
5 discovery and evidence warrants.

6 JURY DEMAND

7 Co- defendant Rick Satcher demands a Jury Trial

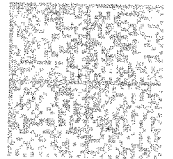
