**DECLARATION OF NEGIN  
INGBRIGTSEN**

Pursuant to 28 U.S.C. § 1746(2), I, Negin Ingbrigtsen, hereby declare as follows:

1. I am over the age of eighteen and competent to testify herein.
2. I am originally from Iran.
3. I am a resident of Washington State and a United States citizen.
4. I came to the United States in 2010 with a diversity visa lottery.
5. I got my United States citizenship in March 2016.
6. I am married to a white American man. We married 3 years ago and have two children, a 23 month old and a 6 week old.

1 7. I submitted green card applications for both of my parents in December 2016 and I am  
2 still waiting for their interview. Because of the first two executive orders preventing  
3 processing of their visas, my parents could not be with me when I gave birth to my child  
4 in August 2017.

5  
6 8. Despite our efforts, I do not have any hope that they will get their visas by October 18,  
7 2017.

9 9. My father and my husband have not been able to meet and if the President's September  
10 24, 2017 Proclamation goes into effect, they never will. I miss my parents so bad. My  
11 husband is too afraid to go to Iran with me. We married without my parents being present  
12 in the United States. There have already been so many precious, important moments in my  
13 life that my parents have had to miss and I will be irreparably harmed if we have to remain  
14 indefinitely separated for the rest of our lives.



16 10. I have spent approximately \$2000 so far in applying for my parents' visas, including  
17 having to obtain visas for them to go to Dubai because it is the closest consulate to them. I  
18 just want my family to be together so that my children can meet their grandparents and my  
19 husband can meet my father.

21 11. I pay taxes and am a good citizen. I just want my parents to live near me or at least be able  
22 to come visit me.

23 I declare under penalty of perjury that the foregoing is true and correct.
