2 IT IS HEREBY STIPULATED by and between all counsel that, subject to Court approval, the
3 deadline for the parties to exchange expert reports shall be extended from September 10, 2018, to
4 October 5, 2018.

5 Pursuant to this Court's Order Setting Trial Dates and Related Dates (Dkt. No. 61), the current
6 deadline for the parties to exchange expert witness disclosures and reports pursuant to FRCP 26(a)(2) is
