1 Although the parties began the process of discovery in July 2017, the parties are
2 continuing to seek medical records from recently identified medical providers relevant to
3 the issue of damages. The parties are also discussing a potential pretrial resolution, and
4 the additional time will allow the parties to explore that possibility prior to incurring the
5 costs of deposing the Plaintiff's and the United States' expert witnesses. Accordingly,
6 the parties respectfully request an extension to May 30, 2018 to produce rebuttal expert
7 reports, and June 30, 2018 to complete discovery. This extension will not effect the trial
8 date scheduled for October 1, 2018.
