2 Joint Status Report and Discovery Plan;

3 5. The Court's ruling on the pending Motion may significantly impact the

5 compliance with the Court's FRCP 26 Order;

6 6. Accordingly, the Parties agree that it serves the interests of judicial economy to  
7 continue by a further thirty (30) days the deadlines in the Court's FRCP 26 Order in order to  
8 allow time for the Motion to be resolved; and

9 7. The Parties respectfully request the Court to continue by a further thirty (30)  
10 days—or for a period of the Court's choosing—the deadlines in the Court's FRCP 26 Order.
