## **STIPULATED MOTION**

On September 30, 2022, the Court approved the parties' stipulation staying proceedings pending mediation in the above-entitled action. *See* Dkt. 366. The parties, by and through their attorneys of record, provide this Joint Status Report and Stipulated Motion to inform the Court that the parties conducted a private mediation on December 13, 2022. Although the parties made progress during that mediation and remain engaged in settlement discussions, they have not yet resolved the case. If settlement efforts fail, the parties will promptly advise the Court and will within ten business days of March 6, 2023 file a Joint
